## A BILL FOR

- 1 An Act allowing counties to collect a fee for the issuance
- 2 and renewal of driver's licenses and nonoperator's
- 3 identification cards to persons who reside outside the
- 4 county.
- 5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 321M.9, subsection 1, paragraph a, Code
- 2 2023, is amended by adding the following new subparagraph:
- 3 NEW SUBPARAGRAPH. (4) The ten-dollar convenience fee
- 4 collected pursuant to subsection 1A.
- 5 Sec. 2. Section 321M.9, Code 2023, is amended by adding the
- 6 following new subsection:
- 7 NEW SUBSECTION. 1A. Convenience fee. A county authorized
- 8 to issue driver's licenses under this chapter may charge, in
- 9 addition to any other fee imposed by law, a convenience fee for
- 10 the issuance or renewal of a driver's license or nonoperator's
- 11 identification card to a person who is not a resident of the
- 12 county, unless that person pays property tax to the county
- 13 and provides proof of payment such as a receipt as provided
- 14 in section 445.5, subsection 6, or another form of proof as
- 15 determined by the county. The convenience fee shall be ten
- 16 dollars.
- 17 EXPLANATION
- 18 The inclusion of this explanation does not constitute agreement with
- 19 the explanation's substance by the members of the general assembly.
- 20 Current law authorizes certain counties to issue driver's
- 21 licenses and nonoperator's identification cards if the county
- 22 meets standards set by the department of transportation. A
- 23 county retains for deposit in the county general fund \$7 of
- 24 fees received for each issuance or renewal of driver's licenses
- 25 and nonoperator's identification cards. This bill allows a
- 26 county authorized to issue driver's licenses to charge a \$10
- 27 convenience fee for the issuance or renewal of a driver's
- 28 license or nonoperator's identification card to a person who
- 29 is not a resident of the county. However, the county cannot
- 30 charge the convenience fee to a nonresident person who pays
- 31 property tax to the county if the person provides proof that
- 32 they paid property tax, such as a receipt from the county
- 33 treasurer or another form of proof as determined by the county.
- 34 The county treasurer retains the entire convenience fee
- 35 collected for deposit in the county general fund.
