A BILL FOR

- 1 An Act relating to the modification of a bridge order issued
- 2 pursuant to a previous child in need of assistance case.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 232.103A, Code 2023, is amended by adding
- 2 the following new subsection:
- NEW SUBSECTION. 6A. a. If a bridge order currently
- 4 exists for a child, a juvenile court may close a child in
- 5 need of assistance case by transferring jurisdiction over the
- 6 child's custody, physical care, and visitation to the district
- 7 court through modification of that bridge order, if all of
- 8 the criteria in section 1, paragraphs "a", "b", "c", and "f",
- 9 are met and the juvenile court has determined that the child
- 10 in need of assistance case can safely close once the child's
- ll previous bridge order is modified and entered by the district
- 12 court.
- 13 b. The modification of a bridge order pursuant to paragraph
- 14 "a" shall designate the petitioner and respondent in the
- 15 existing bridge order as petitioner and respondent in their
- 16 previously designated roles. A modification of a bridge order
- 17 shall only address custody, physical care, and visitation.
- 18 All other matters, including child support, shall be filed by
- 19 separate petition or by action of the child support recovery
- 20 unit, and shall be subject to existing applicable statutory
- 21 provisions.
- c. Filing fees and other court costs shall not be assessed
- 23 against the parties.
- 24 d. The district court shall take judicial notice of the
- 25 juvenile file in any hearing related to the case. Records
- 26 contained in the district court case file that were copied or
- 27 transferred from the juvenile court file concerning the case
- 28 shall be subject to section 232.147 and other confidentiality
- 29 provisions of this chapter for cases not involving juvenile
- 30 delinquency, and shall be disclosed, upon request, to the child
- 31 support recovery unit without a court order.
- 32 EXPLANATION
- 33 The inclusion of this explanation does not constitute agreement with 34 the explanation's substance by the members of the general assembly.
- 35 This bill relates to the ability of a juvenile court to

- 1 close a child in need of assistance (CINA) case by transferring
- 2 jurisdiction through modification of a bridge order issued
- 3 pursuant to a previous CINA case.
- 4 Under current law, a juvenile court may close a CINA case by
- 5 issuing a bridge order that would transfer jurisdiction to the
- 6 district court. If the child is subject to a subsequent CINA
- 7 case, the juvenile court is required to issue a new order for
- 8 the case and a court would have to rescind the previous bridge
- 9 order. The bill provides that if a bridge order currently
- 10 exists for a child in a CINA case, a juvenile court may close
- ll a CINA case by transferring jurisdiction over the child's
- 12 custody, physical care, and visitation to the district court
- 13 through a modification of the bridge order issued pursuant
- 14 to the previous CINA case if the child has been adjudicated
- 15 a CINA in an active juvenile court case, and a dispositional
- 16 order in that case is in place; paternity of the child has been
- 17 legally established, including by operation of law due to the
- 18 individual's marriage to the mother at the time of conception,
- 19 birth, or at any time during the period between conception
- 20 and birth of the child, by order of a court of competent
- 21 jurisdiction, or by administrative order when authorized by
- 22 state law; the child is safely placed by the juvenile court
- 23 with a parent; a parent qualified for a court-appointed
- 24 attorney in the juvenile court case; and the juvenile court has
- 25 determined that the CINA case can safely close once the child's
- 26 previous bridge order is modified and entered by the district
- 27 court.
- 28 The bill requires a bridge order to designate the petitioner
- 29 and respondent in the existing bridge order as petitioner and
- 30 respondent in their previously designated roles.
- 31 The bill restricts the scope of a modification of a bridge
- 32 order to issues pertaining to custody, physical care, and
- 33 visitation. All other matters, including child support, shall
- 34 be filed by separate petition or by action of the child support
- 35 recovery unit, and shall be subject to existing applicable

- 1 statutory provisions.
- 2 The bill waives filing fees and other court costs related
- 3 to the juvenile court transferring jurisdiction to a district
- 4 court pursuant to a modification of a bridge order.
- 5 The bill requires the district court to take judicial notice
- 6 of the juvenile file in any hearing related to the case being
- 7 transferred pursuant to a modification of a bridge order.
- 8 Records contained in the district court case file that were
- 9 copied or transferred from the juvenile court file concerning
- 10 the case are subject to all Code chapter 232 (juvenile justice)
- 11 confidentiality provisions, and must be disclosed, upon
- 12 request, to the child support recovery unit without a court
- 13 order.
