- The inclusion of this explanation does not constitute agreement with

- 28 This bill relates to controlled substances, including

- 31 The bill makes changes to controlled substances schedules
- 32 I, II, and IV in Iowa's uniform controlled substances Act
- 33 (Code chapter 124) and to the precursor substances reporting
- 34 requirement in Code chapter 124B to conform to the specific
- 35 chemical designations of the substances contained in Title 21

- 1 of the Code of Federal Regulations, parts 1300, 1308, and 1310.
- 2 A violation involving a controlled substance included in the
- 3 bill may result in a class "B" felony, and in addition to the
- 4 25-year mandatory minimum term of imprisonment for class "B"
- 5 felons, a fine of not less than \$5,000 nor more than \$100,000;
- 6 a class "C" felony punishable by imprisonment up to 10 years
- 7 and a fine of not less than \$1,000 nor more than \$50,000; or an
- 8 aggravated misdemeanor punishable by imprisonment up to 2 years
- 9 and a fine of at least \$855 but not more than \$8,540.
- 10 The bill takes effect upon enactment.
