- 1 An Act relating to manufacturers and wholesalers of 340B drugs.
- 2 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 510D.1, Code 2024, is amended by adding
- 2 the following new subsections:
- 3 NEW SUBSECTION. 01. "340B drug" means a covered outpatient
- 4 drug for which a manufacturer has offered a reduced price
- 5 pursuant to 42 U.S.C. §256b, and that is purchased by a covered
- 6 entity.
- 7 NEW SUBSECTION. 5A. "Manufacturer" means the same as
- 8 defined in section 1927(k)(5) of the federal Social Security
- 9 Act.
- 10 NEW SUBSECTION. 10. "Wholesaler" means the same as defined
- 11 in section 1927(k)(11) of the federal Social Security Act.
- 12 Sec. 2. Section 510D.2, Code 2024, is amended by adding the
- 13 following new subsection:
- 14 NEW SUBSECTION. 4. A manufacturer or wholesaler shall not
- 15 do any of the following:
- 16 a. Either directly or indirectly deny, restrict, or
- 17 otherwise interfere with the acquisition or purchase of a
- 18 340B drug by a covered entity, or delivery of a 340B drug
- 19 to a contract pharmacy, unless such purchase or receipt is
- 20 prohibited by the United States department of health and human
- 21 services.
- 22 b. Impose reporting requirements or restrictive contract
- 23 terms that are not required by law in order for a covered
- 24 entity or a contract pharmacy to purchase and receive 340B
- 25 drugs.
- 26 EXPLANATION
- 27 The inclusion of this explanation does not constitute agreement with
- the explanation's substance by the members of the general assembly.
- This bill relates to manufacturers and wholesalers of 340B 30 drugs.
- 31 "340B drug", "manufacturer", and "wholesaler" are defined
- 32 in the bill. The bill prohibits a manufacturer or wholesaler
- 33 from, directly or indirectly, denying, restricting, or
- 34 interfering with either the acquisition or purchase of a 340B
- 35 drug by a covered entity, or the delivery of a 340B drug to a

- 1 contract pharmacy, unless otherwise prohibited by the United
- 2 States department of health and human services. The bill
- 3 prohibits a manufacturer or wholesaler from requiring reporting
- 4 requirements or imposing contractual restrictions that are
- 5 not required by law in order for a covered entity or contract
- 6 pharmacy to purchase and receive 340B drugs.
