## A BILL FOR

- 1 An Act relating to Gadsden flag special registration plates.
- 2 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 321.34, Code 2024, is amended by adding 2 the following new subsection:
- 3 NEW SUBSECTION. 11E. Gadsden flag plates.
- 4 a. Upon application and payment of the proper fees, the
- 5 director may issue Gadsden flag plates to the owner of a
- 6 motor vehicle subject to registration under section 321.109,
- 7 subsection 1, autocycle, motor truck, motor home, multipurpose
- 8 vehicle, motorcycle, trailer, or travel trailer.
- 9 b. Gadsden flag plates shall be designed by the department.
- 10 The background shall be yellow at the top and bottom, with the
- 11 color fading into white in the center. The plate's numbers
- 12 and letters shall be black. The left side of the plate shall
- 13 depict a black and white rattlesnake coiled on green grass.
- 14 The image depicting the coiled rattlesnake shall be at least
- 15 three inches tall and two inches wide. The phrase "Don't Tread
- 16 on Me" shall appear at the bottom of the plate.
- 17 c. The special Gadsden flag fee for letter-number designated
- 18 Gadsden flag plates is thirty-five dollars. An applicant may
- 19 obtain personalized Gadsden flag plates upon payment of the
- 20 fee for personalized plates as provided in subsection 5, which
- 21 is in addition to the special Gadsden flag fee. Personalized
- 22 plates authorized by this subsection shall be limited to no
- 23 more than five numerals, letters, or combinations of numerals
- 24 and letters.
- 25 d. The fees collected by the director under this subsection
- 26 shall be paid monthly to the treasurer of state and deposited
- 27 in the road use tax fund. The treasurer of state shall
- 28 transfer monthly from the statutory allocations fund created
- 29 under section 321.145, subsection 2, to the general fund of the
- 30 state the amount of the special fees collected in the previous
- 31 month for Gadsden flag plates. Such moneys are appropriated to
- 32 the department of public safety to distribute in the form of
- 33 grants to provide education and training on the right to keep
- 34 and bear arms protected under the Constitution of the United
- 35 States and the Constitution of the State of Iowa. In the

- 1 awarding of grants, the department of public safety shall give
- 2 first consideration to any official state association of the
- 3 national rifle association and similar nonprofit organizations.
- 4 Notwithstanding section 8.33, moneys appropriated under this
- 5 subsection shall not revert to the general fund of the state.
- 6 e. Upon receipt of the special registration plates, the
- 7 applicant shall surrender the current registration plates to
- 8 the county treasurer. The county treasurer shall validate
- 9 the special registration plates in the same manner as regular
- 10 registration plates are validated under this section. The
- 11 annual special Gadsden flag fee for letter-number designated
- 12 plates is ten dollars which shall be paid in addition to
- 13 the regular annual registration fee. The annual fee for
- 14 personalized Gadsden flag plates is five dollars which shall be
- 15 paid in addition to the annual special Gadsden flag fee and the
- 16 regular annual registration fee. The annual special Gadsden
- 17 flag fee shall be credited as provided under paragraph "d".
- 18 f. The department shall not condition the issuance of
- 19 Gadsden flag plates on the receipt of any number of orders for
- 20 Gadsden flag plates.
- 21 Sec. 2. Section 321.166, subsections 2 and 9, Code 2024, are
- 22 amended to read as follows:
- 23 2. Every registration plate or pair of plates shall display
- 24 a registration plate number which shall consist of alphabetical
- 25 or numerical characters or a combination thereof and the name
- 26 of this state, which may be abbreviated. Every registration
- 27 plate issued by the county treasurer shall display the name
- 28 of the county, including any plate issued pursuant to section
- 29 321.34, except Pearl Harbor and purple heart registration
- 30 plates issued prior to January 1, 1997; and collegiate, fire
- 31 fighter, and medal of honor, and Gadsden flag registration
- 32 plates. Special truck registration plates shall display the
- 33 word "special". The department may adopt rules to implement
- 34 this subsection.
- 35 9. Special registration plates issued pursuant to section

1 321.34, other than gold star, medal of honor, collegiate, fire

2 fighter, natural resources, blackout, and flying our colors,

3 and Gadsden flag registration plates, shall be consistent with

4 the design and color of regular registration plates but shall

5 provide a space on a portion of the plate for the purpose of

6 allowing the placement of a distinguishing processed emblem or

7 an organization decal. Special registration plates shall also

8 comply with the requirements for regular registration plates

9 as provided in this section to the extent the requirements are

10 consistent with the section authorizing a particular special

11 vehicle registration plate.

## 12 EXPLANATION

The inclusion of this explanation does not constitute agreement with the explanation's substance by the members of the general assembly.

This bill authorizes the department of transportation (DOT)

16 to design and issue Gadsden flag special registration plates.

17 The bill requires the plate's background to be yellow at the

18 top and bottom, with the color fading into white in the center.

19 The plate's numbers and letters must be black. The left side

20 of the plate must contain the image of a rattlesnake in black

21 and white coiled on green grass. The phrase "Don't Tread on

22 Me" must appear at the bottom of the plate.

23 The bill provides that the special Gadsden flag fee for

24 letter-number designated Gadsden flag plates is \$35. An

25 applicant may obtain personalized Gadsden flag plates upon

26 payment of the \$25 fee for personalized plates set forth under

27 current law, which is in addition to the special Gadsden flag

28 fee. Personalized Gadsden flag plates are limited to five

29 numerals and letters. The annual special Gadsden flag fee for

30 letter-number designated plates is \$10, which is in addition

31 to the regular annual registration fee. The annual fee for

32 personalized Gadsden flag plates is \$5, which is in addition

33 to the annual special Gadsden flag fee and the regular annual

34 registration fee.

35 The fees collected by the DOT must be paid monthly to the

- 1 treasurer of state and deposited in the road use tax fund. The
- 2 treasurer of state must transfer monthly from the statutory
- 3 allocations fund to the general fund of the state the amount
- 4 of the special fees collected in the previous month for the
- 5 Gadsden flag plates. Such moneys are appropriated to the
- 6 department of public safety (DPS) to distribute in the form of
- 7 grants to provide education and training on the right to keep
- 8 and bear arms. In the awarding of grants, DPS must give first
- 9 consideration to any official state association of the national
- 10 rifle association and similar nonprofit organizations.
- 11 The bill prohibits the DOT from conditioning the issuance of
- 12 Gadsden flag plates on the receipt of any number of orders for
- 13 Gadsden flag plates.
- 14 Gadsden flag plates are exempt from the general requirements
- 15 to display the name of the county that issues the plates and to
- 16 be consistent with the design and color of regular registration
- 17 plates.
- 18 Under current law, nonprofit organizations are authorized
- 19 to apply to the DOT for approval to issue a decal of the
- 20 organization's own design to be displayed on special
- 21 registration plates with space reserved for an organizational
- 22 decal. The nonprofit organization may charge a fee and retain
- 23 any payment received for the organizational decal. Code
- 24 section 321.34(13) sets forth the application process and
- 25 certain limitations for nonprofit organizations and decal
- 26 designs.
