A BILL FOR

- 1 An Act relating to building design element regulation by
- 2 governmental subdivisions, and including effective date
- 3 provisions.
- 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. <u>NEW SECTION</u>. 103A.8D Design element regulation
- 2 by governmental subdivisions.
- 3 1. For purposes of this section:
- 4 a. "National model code" includes any of the last two
- 5 publications of the following codes that apply to the
- 6 construction, renovation, maintenance, or other alteration of a
- 7 building or structure:
- 8 (1) The international building code, as adopted under 661
- 9 IAC ch. 201 and 661 IAC ch. 301.
- 10 (2) The international residential code, as adopted under
- 11 661 IAC ch. 301.
- 12 (3) The international existing building code, as adopted
- 13 under 661 IAC ch. 301 and 661 IAC ch. 350.
- 14 (4) The international energy conservation code, as adopted
- 15 under 661 IAC ch. 303.
- 16 (5) Any code published by the national fire protection
- 17 association.
- 18 (6) The building construction safety code.
- 19 (7) The uniform plumbing code, as adopted under 641 IAC ch.
- 20 25.
- 21 (8) The national electrical code, as adopted under 661 IAC
- 22 ch. 504.
- 23 (9) The international property maintenance code.
- 24 b. "Residential building" means any single or multifamily
- 25 residential dwelling and includes single-family and two-family
- 26 dwellings and townhouses; condominiums and apartments with
- 27 a maximum of twelve units per building; and all secondary
- 28 structures to such a single or multifamily residential
- 29 dwelling.
- 30 c. (1) "Residential building design element" means any of
- 31 the following:
- 32 (a) The type or style of exterior cladding or finish
- 33 materials.
- 34 (b) The style or materials used to construct a roof,
- 35 provided the style or materials comply with all applicable fire

- 1 and safety codes.
- 2 (c) Exterior nonstructural architectural ornamentation.
- 3 (d) The location, design, placement, or architectural
- 4 styling of windows and doors including garage doors and garage
- 5 structures, provided the location, design, placement, or
- 6 architectural styling complies with all applicable fire and
- 7 safety codes.
- 8 (e) The number and types of rooms, provided the number or
- 9 type complies with all applicable fire and safety codes.
- 10 (f) The interior layout of rooms, provided the interior
- 11 layout complies with all applicable fire and safety codes.
- 12 (q) The minimum square footage of a structure.
- 13 (2) "Residential building design element" does not include
- 14 any of the following:
- 15 (a) The height, bulk, orientation, or location of a
- 16 structure on a lot.
- 17 (b) Buffering or screening elements located at the
- 18 perimeter of the property that are used for any of the
- 19 following purposes:
- 20 (i) Minimizing visual impacts.
- 21 (ii) Mitigating the impacts of light and noise.
- 22 (iii) Protecting the privacy of neighbors.
- 23 2. A governmental subdivision shall not adopt or enforce a
- 24 rule, charter provision, ordinance, order, building code, or
- 25 other regulation that does any of the following:
- 26 a. Prohibits or limits, directly or indirectly, the use
- 27 or installation of a building product or material in the
- 28 construction, renovation, maintenance, or other alteration
- 29 of a residential building or structure, including secondary
- 30 structures or improvements ancillary to such building or
- 31 structure, if the building product or material is approved
- 32 for use by a national model code and the building product or
- 33 material has not been removed from a national model code for
- 34 failing to meet fire and safety standards.
- 35 b. Establishes a standard for a building product, material,

- 1 or aesthetic method in construction, renovation, maintenance,
- 2 or other alteration of a residential building or structure,
- 3 including secondary structures or improvements ancillary to
- 4 such building or structure, if the standard is more stringent
- 5 than a standard for the product, material, or aesthetic method
- 6 under a national model code.
- 7 c. Establishes a new, or amends an existing, residential
- 8 building design element requirement unless any of the following
- 9 conditions apply:
- 10 (1) The residential building is any of the following:
- 11 (a) Located in an area formally designated and declared as a
- 12 state or local historic district under applicable law.
- 13 (b) Designated as a local, state, or national historic
- 14 landmark.
- 15 (c) Located on a property that is governed by a policy or
- 16 regulation as set forth within a duly adopted tax increment
- 17 finance district or a business improvement district.
- 18 (d) Located on a property that is governed by a policy or
- 19 regulation of an overlay or a special purpose zoning district
- 20 that is adopted pursuant to applicable law.
- 21 (2) The requirement directly and substantially relates to
- 22 the safety of life or property or the requirement is adopted as
- 23 a condition for participation in the national flood insurance
- 24 program.
- 25 3. This section does not prohibit or diminish the rights
- 26 of private parties to enact regulations as created by valid
- 27 private covenants or other contractual agreements among
- 28 property owners relating to residential building design
- 29 elements including but not limited to restrictive covenants
- 30 and declarations such as those created under chapter 499B or
- 31 otherwise permitted under Iowa law.
- 32 Sec. 2. EFFECTIVE DATE. This Act, being deemed of immediate
- 33 importance, takes effect upon enactment.
- 34 EXPLANATION
- 35 The inclusion of this explanation does not constitute agreement with

the explanation's substance by the members of the general assembly. 1 2 This bill relates to the regulation of building design 3 elements by governmental subdivisions. The bill defines 4 "national model code", "residential building", and "residential 5 building design element". The bill prohibits a governmental subdivision from adopting 7 or enforcing a rule, charter provision, ordinance, order, 8 building code, or other regulation that governs building design 9 elements in three primary manners. First, a governmental 10 subdivision cannot prohibit or limit the use or installation of 11 a building product or material in the construction, renovation, 12 maintenance, or other alteration of a residential building 13 or structure if the building product or material is approved 14 for use by an applicable, recently published national model 15 code and the building product or material has not been removed 16 from a national model code for failing to meet fire and 17 safety standards. Second, a governmental subdivision cannot 18 establish a standard for a building product, material, or 19 aesthetic method in construction, renovation, maintenance, or 20 other alteration of a residential building or structure if the 21 standard is more stringent than a standard for the product, 22 material, or aesthetic method under a recently published 23 national model code. Third, a governmental subdivision cannot 24 establish a new, or amend an existing, residential building 25 design element requirement unless certain conditions apply to 26 either the building or the requirement. The bill does not prohibit or diminish the rights of private 27 28 parties to enact regulations as created by valid private 29 covenants or other contractual agreements among property owners 30 relating to residential building design elements including but 31 not limited to restrictive covenants and declarations such as 32 those relating to condominiums or otherwise permitted under 33 Iowa law. 34 The bill takes effect upon enactment.
