A BILL FOR

- 1 An Act relating to driver's license privileges for students who

- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 299.1B, Code 2024, is amended to read as 2 follows:
- 3 299.1B Failure to attend driver's license.
- 4 l. A person who is of compulsory attendance age who does
- 5 not meet the requirements for an exception under section
- 6 299.2, who does not attend a public school or an accredited
- 7 nonpublic school, who is not receiving competent private
- 8 instruction or independent private instruction in accordance
- 9 with the provisions of chapter 299A, and who does not attend
- 10 an alternative school or adult education classes, shall not
- ll receive an intermediate or full driver's license until age
- 12 eighteen.
- 2. A person of compulsory attendance age who is deemed
- 14 to be a truant as described in section 299.8 for ten percent
- 15 or more of the days in a semester or term of a school year
- 16 or instruction year shall not receive an intermediate or
- 17 full driver's license until age eighteen. If the person has
- 18 already received an intermediate or full driver's license, the
- 19 department of transportation shall suspend the license until
- 20 the person is age eighteen. The board of directors of a public
- 21 school district, the authorities in charge of an accredited
- 22 nonpublic school, or any other person providing instruction
- 23 to a person as described in subsection 1 who is truant to the
- 24 extent described in this subsection shall promptly report
- 25 the person to the department of transportation in a manner
- 26 prescribed by the department.
- 27 Sec. 2. Section 321.213B, Code 2024, is amended to read as
- 28 follows:
- 29 321.213B Suspension for failure to attend.
- 30 The department shall establish procedures by rule for
- 31 suspending the license of a juvenile who has been issued a
- 32 driver's license and is not in compliance with the requirements
- 33 of section 299.1B, declining to issue a license to such a
- 34 juvenile, or, if applicable, issuing the juvenile a restricted
- 35 license under section 321.178.

1	EXPLANATION
2	The inclusion of this explanation does not constitute agreement with
3	the explanation's substance by the members of the general assembly.
4	This bill provides that a person of compulsory attendance
5	age who is deemed to be a truant for 10 percent or more of the
6	days in a semester or term of a school year or instruction
7	year shall not receive an intermediate or full driver's
8	license until age 18. If the person has already received an
9	intermediate or full driver's license, the bill requires the
10	department of transportation to suspend the license until
11	the person is age 18. The school board, the authorities in
12	charge of an accredited nonpublic school, or any other person
13	providing instruction to a person who is truant to the extent
14	described in the bill shall promptly report the person to the
15	department of transportation.
