**A BILL FOR**

1 An Act relating to parole and probation standards for a person  
2 convicted of certain child endangerment offenses.  
3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section 906.4, subsection 2, Code 2024, is  
2 amended by adding the following new paragraph:

3 NEW PARAGRAPH. *c.* A person on parole or work release who  
4 is serving a sentence under section 726.6, subsection 5, 6,  
5 or 7, shall not be permitted to have unsupervised access to a  
6 child or minor, including accepting, undertaking, or assuming  
7 supervision of a child or minor with or without the explicit  
8 consent of the parent or guardian of the child or minor.

9 Sec. 2. Section 907.6, Code 2024, is amended to read as  
10 follows:

11 **907.6 Conditions of probation — regulations.**

12 Probationers are subject to the conditions established by  
13 the judicial district department of correctional services  
14 subject to the approval of the court, and any additional  
15 reasonable conditions ~~which~~ that the court or district  
16 department may impose to promote rehabilitation of the  
17 defendant or protection of the community. Conditions may  
18 include but are not limited to adherence to regulations  
19 generally applicable to persons released on parole and  
20 including requiring unpaid community service as allowed  
21 pursuant to [section 907.13](#). A probationer convicted of child  
22 endangerment under section 726.6 shall not be permitted to have  
23 unsupervised access to a child or minor, including accepting,  
24 undertaking, or assuming supervision of a child or minor with  
25 or without the explicit consent of the parent or guardian of  
26 the child or minor.

EXPLANATION

28 The inclusion of this explanation does not constitute agreement with

30 This bill relates to parole and probation standards for a  
31 person convicted of certain child endangerment offenses.

32 The bill provides that a person on parole or work release who  
33 is serving a sentence under Code section 726.6, subsection 5  
34 (child endangerment resulting in death), 6 (child endangerment  
35 resulting in serious injury), or 7 (child endangerment

1 resulting in bodily injury), shall not be permitted to have  
2 unsupervised access to a child or minor, including accepting,  
3 undertaking, or assuming supervision of a child or minor with  
4 or without the explicit consent of the parent or guardian of  
5 the child or minor.

6 The bill provides that a probationer convicted of child  
7 endangerment under Code section 726.6 shall not be permitted  
8 to have unsupervised access to a child or minor, including  
9 accepting, undertaking, or assuming supervision of a child or  
10 minor with or without the explicit consent of the parent or  
11 guardian of the child or minor.
