## A BILL FOR

- 1 An Act relating to motor vehicle enforcement duties of
- 2 the department of public safety and the department of
- 3 transportation, providing transfers of moneys, and including
- 4 effective date provisions.
- 5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 80.5, subsection 2, Code 2023, is amended 2 to read as follows:
- 3 2. The state patrol is established in the department. The
- 4 patrol shall be under the direction of the commissioner. The
- 5 number of supervisory officers shall be in proportion to the
- 6 membership of the state patrol. The department shall maintain
- 7 a vehicle theft unit in the state patrol to investigate
- 8 and assist in the examination and identification of stolen,
- 9 altered, or forfeited vehicles. In addition to other duties,
- 10 powers, and responsibilities prescribed by law, the state
- 11 patrol shall conduct enforcement activities that ensure the
- 12 safe and lawful movement and operation of commercial motor
- 13 vehicles and vehicles transporting loads, including but not
- 14 limited to the enforcement of motor vehicle laws relating to
- 15 the operating authority, registration, size, weight, and load
- 16 of motor vehicles and trailers.
- 17 Sec. 2. Section 80.5, Code 2023, is amended by adding the
- 18 following new subsections:
- 19 NEW SUBSECTION. 10. The department of public safety
- 20 shall adopt, after consultation with the department of
- 21 transportation, rules relating to enforcement of motor vehicle
- 22 laws, including but not limited to laws governing the safe
- 23 movement and operation of commercial motor vehicles and
- 24 vehicles transporting loads. The state patrol shall carry out
- 25 the enforcement of the rules, in accordance with state law.
- 26 NEW SUBSECTION. 11. The department of public safety shall
- 27 adopt, after consultation with the department of natural
- 28 resources and the department of transportation, rules relating
- 29 to enforcement of the rules regarding transportation of
- 30 hazardous wastes adopted by the department of natural resources
- 31 and the department of transportation. The state patrol shall
- 32 carry out the enforcement of the rules, in accordance with
- 33 state law.
- NEW SUBSECTION. 12. The department shall submit a report to
- 35 the general assembly on or before December 1 of each year that

- 1 details the nature and scope of enforcement activities that
- 2 ensure the safe and lawful movement and operation of commercial
- 3 motor vehicles and vehicles transporting loads conducted by
- 4 members of the state patrol assigned to such enforcement
- 5 activities in the previous year. The report shall include
- 6 a comparison of commercial and noncommercial motor vehicle
- 7 enforcement activities conducted by such members of the state
- 8 patrol.
- 9 Sec. 3. Section 80B.6, subsection 1, paragraph k, Code 2023,
- 10 is amended to read as follows:
- 11 k. A member of the office of motor vehicle enforcement of
- 12 the department of transportation involved with the enforcement
- 13 activities set forth in section 321.477.
- 14 Sec. 4. Section 97B.42B, Code 2023, is amended by adding the
- 15 following new subsection:
- 16 NEW SUBSECTION. 4A. a. Commencing July 1, 2023, a
- 17 person who is a designated peace officer in the department of
- 18 transportation under section 321.477, Code 2023, as of June 30,
- 19 2023, who has fewer than ten years of membership service, and
- 20 who is transferred to the department of public safety pursuant
- 21 to this Act, shall be a member of the Iowa department of public
- 22 safety peace officers' retirement, accident, and disability
- 23 system established in chapter 97A.
- 24 b. Commencing July 1, 2023, a person who is a designated
- 25 peace officer in the department of transportation under section
- 26 321.477, Code 2023, as of June 30, 2023, who has ten or more
- 27 years of membership service, and who is transferred to the
- 28 department of public safety pursuant to this Act, shall remain
- 29 a member of the Iowa public employees' retirement system.
- 30 Sec. 5. Section 97B.49B, subsection 1, paragraph e,
- 31 subparagraph (5), Code 2023, is amended to read as follows:
- 32 (5) (a) An employee of the state department of
- 33 transportation who is designated as a "peace officer" by
- 34 resolution under section 321.477, but only if the employee
- 35 retires on or after July 1, 1990. For purposes of this

- 1 subparagraph, service as a traffic weight officer employed
- 2 by the highway commission prior to the creation of the state
- 3 department of transportation or as a peace officer employed by
- 4 the Iowa state commerce commission prior to the creation of
- 5 the state department of transportation shall be included in
- 6 computing the employee's years of membership service.
- 7 (b) An employee of the department of public safety described
- 8 in section 97B.42B, subsection 4A, paragraph "b".
- 9 Sec. 6. Section 152C.5B, subsection 1, paragraph b,
- 10 subparagraph (5), Code 2023, is amended by striking the
- 11 subparagraph.
- 12 Sec. 7. Section 157.4A, subsection 1, paragraph b,
- 13 subparagraph (5), Code 2023, is amended by striking the
- 14 subparagraph.
- 15 Sec. 8. Section 307.12, subsection 1, paragraph n, Code
- 16 2023, is amended to read as follows:
- 17 n. Adopt, after consultation with the department of
- 18 natural resources and the department of public safety, rules
- 19 relating to enforcement of the rules regarding transportation
- 20 of hazardous wastes adopted by the department of natural
- 21 resources. The department of transportation and the division
- 22 of state patrol of the department of public safety shall carry
- 23 out the enforcement of the rules, as otherwise authorized by
- 24 law.
- Sec. 9. Section 307.48, Code 2023, is amended by adding the
- 26 following new subsection:
- 27 NEW SUBSECTION. 3. An employee of the office of motor
- 28 vehicle enforcement of the department of transportation on June
- 29 30, 2023, who is transferred to the department of public safety
- 30 pursuant to this Act, retains all rights to longevity pay.
- 31 Sec. 10. Section 321.2, subsection 2, Code 2023, is amended
- 32 to read as follows:
- 33 2. The division of state patrol of the department of public
- 34 safety shall enforce the provisions of this chapter, rules
- 35 adopted by the department of transportation, and rules adopted

- 1 by the department of public safety relating to traffic on the
- 2 public highways of the state, including those relating to the
- 3 safe and legal operation of passenger cars, motorcycles, motor
- 4 trucks, and buses, and other commercial motor vehicles, and to
- 5 see that proper safety rules are observed.
- 6 Sec. 11. Section 321.266, subsection 4, Code 2023, is
- 7 amended to read as follows:
- 8 4. Notwithstanding section 455B.386, a carrier transporting
- 9 hazardous material upon a public highway in this state, in
- 10 the case of an accident involving the transportation of the
- 11 hazardous material, shall immediately notify the police radio
- 12 broadcasting system established pursuant to section 693.1 or
- 13 shall notify a peace officer of the county or city in which
- 14 the accident occurs. When a local law enforcement agency is
- 15 informed of the accident, the agency shall notify the state
- 16 patrol and the state department of transportation office of
- 17 motor vehicle enforcement. A person who violates a provision
- 18 of this subsection is quilty of a serious misdemeanor.
- 19 Sec. 12. Section 321.449, subsection 8, Code 2023, is
- 20 amended to read as follows:
- 21 8. In the course of enforcing the motor carrier safety
- 22 rules adopted by the department of transportation under chapter
- 23 17A, the department's department of public safety's peace
- 24 officers are authorized, at reasonable times and places and
- 25 with reasonable notice, to enter a motor carrier's place of
- 26 business for the purpose of performing a motor carrier safety
- 27 audit or compliance review. Nothing in this subsection by
- 28 itself permits the seizure of the property of a motor carrier.
- 29 Any audit or review shall be conducted in compliance with the
- 30 federal motor carrier safety regulations in 49 C.F.R. pts. 105
- 31 185, 382, 383, 385, and 390 399. A peace officer of the
- 32 department of public safety is authorized to inspect and copy
- 33 motor carrier records required by 49 C.F.R. pts. 105 185,
- 34 382, 383, 385, and 390 399.
- 35 Sec. 13. Section 321.450, subsection 1, Code 2023, is

- 1 amended to read as follows:
- A person shall not transport or have transported or
- 3 shipped within this state any hazardous material except
- 4 in compliance with rules adopted by the department of
- 5 transportation, in consultation with the department of natural
- 6 resources, under chapter 17A. The rules shall be consistent
- 7 with the federal hazardous materials regulations adopted under
- 8 United States Code, Tit. 49, and found in 49 C.F.R. pts. 107,
- 9 171 to 173, 177, 178, and 180.
- 10 Sec. 14. Section 321.463, subsection 5, paragraph b, Code
- 11 2023, is amended to read as follows:
- 12 b. Notwithstanding any provision of law to the contrary,
- 13 a motor vehicle described in paragraph "a" equipped with an
- 14 auxiliary power or idle reduction technology unit that reduces
- 15 fuel use and emissions during engine idling may exceed any
- 16 applicable maximum gross weight limit under this chapter by
- 17 five hundred fifty pounds or the weight of the auxiliary power
- 18 or idle reduction technology unit, whichever is less. This
- 19 paragraph "b" shall does not apply unless the operator of
- 20 the vehicle provides to the department of public safety a
- 21 written certification of the weight of the auxiliary power
- 22 or idle reduction technology unit, demonstrates or certifies
- 23 to the department of public safety that the idle reduction
- 24 technology unit is fully functional at all times, and carries
- 25 with the operator the written certification of the weight of
- 26 the auxiliary power or idle reduction technology unit in the
- 27 vehicle at all times to present to law enforcement in the event
- 28 the vehicle is suspected of violating any applicable weight
- 29 restrictions.
- 30 Sec. 15. Section 321.476, subsection 1, Code 2023, is
- 31 amended to read as follows:
- 32 1. a. Authority is hereby given to the A member of the
- 33 state patrol of the department to stop of public safety is
- 34 authorized to do any of the following:
- 35 a. Stop any motor vehicle or trailer on the highways for the

- 6 and inspection, Weigh and inspect vehicles which have moved
- 7 from a highway onto private property under circumstances which
- 8 indicate that the load of the vehicle, if any, is substantially
- 9 the same as the load which the vehicle carried before moving
- 10 onto the private property.
- 11 Sec. 16. Section 321.477, Code 2023, is amended to read as
- 12 follows:
- 321.477 Employees as peace officers maximum age.
- 1. The department may designate by resolution certain of its
- 15 employees upon each of whom there is conferred the authority
- 16 of a peace officer to enforce all laws of the state including
- 17 but not limited to the rules and regulations of the department
- 18 investigate and enforce all of the following:
- 19 a. Laws relating to motor vehicle records, documents,
- 20 credentials, procedures, and revenues, including but not
- 21 limited to crimes and abuse of authority associated with
- 22 fraud, identity theft, vehicle titles and registration, dealer
- 23 licenses, and authorized vehicle recycler licenses.
- 24 b. Laws relating to motor vehicle fraud including but not
- 25 limited to the state and federal odometer laws, including as
- 26 provided in sections 307.37 and 321.71.
- 27 2. Employees designated as peace officers pursuant to this
- 28 section shall have the same powers conferred by law on peace
- 29 officers for the enforcement of all laws of this state and the
- 30 apprehension of violators.
- 31 2. Employees designated as peace officers pursuant to this
- 32 section who are assigned to the supervision of the highways
- 33 of this state shall spend the preponderance of their time
- 34 conducting enforcement activities that assure the safe and
- 35 lawful movement and operation of commercial motor vehicles and

- 1 vehicles transporting loads, including but not limited to the
- 2 enforcement of motor vehicle laws relating to the operating
- 3 authority, registration, size, weight, and load of motor
- 4 vehicles and trailers, and registration of a motor carrier's
- 5 interstate transportation service with the department.
- 6 3. Employees designated as peace officers pursuant to
- 7 this section shall not exercise the general powers of a peace
- 8 officer set forth in this section within the limits of any
- 9 city, except as follows:
- 10 a. When so ordered by the direction of the governor.
- 11 b. When request is made by the mayor of any city, with the
- 12 approval of the director.
- c. When request is made by the sheriff or county attorney of
- 14 any county, with the approval of the director.
- 15 d. While in the pursuit of law violators or in investigating
- 16 law violations.
- 17 e. While making any inspection provided by this chapter, or
- 18 any additional inspection ordered by the director.
- 19 f. When engaged in the investigation and enforcement of laws
- 20 relating to narcotic, counterfeit, stimulant, and depressant
- 21 drugs.
- 22 4. The limitations specified in subsection 3 shall in no
- 23 way be construed as a limitation on the power of employees
- 24 designated as peace officers pursuant to this section when a
- 25 public offense is being committed in their presence.
- 26 5. The department shall submit a report to the general
- 27 assembly on or before December 1 of each year that details the
- 28 nature and scope of enforcement activities conducted in the
- 29 previous fiscal year by employees designated as peace officers
- 30 pursuant to this section who are assigned to the supervision
- 31 of the highways of this state. The report shall include a
- 32 comparison of commercial and noncommercial motor vehicle
- 33 enforcement activities conducted by such employees.
- 34 6. 4. The maximum age for a person employed as a peace
- 35 officer pursuant to this section is sixty-five years of age.

- 1 Sec. 17. Section 321.481, Code 2023, is amended to read as 2 follows:
- 3 321.481 No impairment of other authority.
- 4 Nothing in sections 321.476 through <del>321.480</del> 321.479 shall be
- 5 so construed as to limit or impair the authority or duties of
- 6 other peace officers in the enforcement of the motor vehicle
- 7 laws or any portion thereof.
- 8 Sec. 18. Section 325A.10, Code 2023, is amended to read as 9 follows:
- 10 325A.10 Rules for operation.
- 11 1. The department shall adopt rules pursuant to chapter
- 12 17A as necessary to govern and control the operation, and
- 13 maintenance, and inspection of vehicles covered by this chapter
- 14 upon the highways.
- 15 2. The department of public safety shall adopt rules
- 16 pursuant to chapter 17A as necessary to govern the inspection

- 29 Sec. 21. REPEAL. Sections 321.480 and 327B.2, Code 2023,

- 31 Sec. 22. TRANSFERS.
- 32 l. There is transferred from the department of
- 33 transportation's asset forfeiture fund to the department
- 34 of public safety's asset forfeiture fund the amount of
- 35 unencumbered or unobligated moneys remaining in the department

- 1 of transportation's asset forfeiture fund.
- 2. The amount transferred pursuant to subsection 1 shall be
- 3 used in compliance with applicable law for costs incurred by
- 4 the department of public safety for the transition provided for
- 5 in this Act.
- 6 3. a. The Iowa public employees' retirement system
- 7 shall perform a trustee-to-trustee lump sum transfer to the
- 8 Iowa department of public safety peace officers' retirement,
- 9 accident, and disability system. The transfer shall include an
- 10 amount consisting of the accumulated contributions by members
- 11 transferred to the peace officers' retirement, accident, and
- 12 disability system pursuant to this Act and every transferred

- 21 actuarial cost of the remaining transfer. For purposes of this
- 22 paragraph, "the actuarial cost of the remaining transfer" is an
- 23 amount determined by the peace officers' retirement, accident,
- 24 and disability system in accordance with actuarial tables which
- 25 reflects the actuarial cost necessary to fund the increased
- 26 retirement allowances less the amount transferred by the Iowa
- 27 public employees' retirement system.
- 28 c. Once the transfer is completed, the transferred members
- 29 shall forfeit all rights, including service credit and
- 30 benefits, under chapter 97B; shall be treated as members under
- 31 chapter 97A; and shall be vested in a benefit under chapter 97A
- 32 that shall not be less than the benefit to which the member was
- 33 entitled under chapter 97B at the time of the transfer.

- 35 transportation shall provide all appropriate documentation

- The inclusion of this explanation does not constitute agreement with the explanation's substance by the members of the general assembly.
- 8 BACKGROUND. Under current law, the department of public
- 9 safety (DPS) is charged with, among other things, preventing
- 10 crime and detecting and apprehending criminals. The division
- 11 of state patrol (state patrol) is established within DPS. The
- 12 state patrol is required to enforce the provisions of Code
- 13 chapter 321 (motor vehicles and law of the road) relating
- 14 to traffic on public highways, including those relating to
- 15 the safe and legal operation of passenger cars, motorcycles,
- 16 motor trucks, and buses, and to see that proper safety rules
- 17 are observed. In addition, the state patrol must investigate
- 18 and assist in the examination and identification of stolen,
- 19 altered, or forfeited vehicles.
- The department of transportation (DOT) is responsible
- 21 for the planning, development, regulation, and improvement
- 22 of transportation as provided by law. DOT is authorized to
- 23 designate certain employees as peace officers, who are assigned
- 24 to DOT's office of motor vehicle enforcement (MVE). MVE
- 25 officers must spend the preponderance of their time conducting
- 26 enforcement activities that assure the safe and lawful
- 27 movement and operation of commercial motor vehicles (CMVs) and
- 28 vehicles transporting loads, including but not limited to the
- 29 enforcement of motor vehicle laws relating to the operating
- 30 authority, registration, size, weight, and load of motor
- 31 vehicles and trailers, and registration of a motor carrier's
- 32 interstate transportation service with DOT.
- DOT and DPS are required to cooperate to ensure the proper
- 34 and adequate enforcement of the provisions of Code chapter 321.
- 35 TRANSITION DOT TO DPS. This bill provides for the

- 1 transition of certain MVE employees from DOT to DPS.
- 2 Effective July 1, 2023, DPS peace officers will assume the
- 3 responsibilities and duties of MVE officers so transferred.
- 4 On or before July 1, 2023, DOT and DPS, in consultation with
- 5 the department of administrative services, must identify and
- 6 transfer affected positions and incumbent civilian and MVE
- 7 officer employees from DOT to DPS. Transferred MVE peace
- 8 officers will become peace officers in the state patrol.
- 9 The bill transfers to the state patrol responsibility for,
- 10 among other duties, conducting enforcement activities that
- ll ensure the safe and lawful movement and operation of CMVs
- 12 and vehicles transporting loads. The state patrol is tasked
- 13 with enforcing motor vehicle laws relating to the operating
- 14 authority, registration, size, weight, and load of motor
- 15 vehicles and trailers, and enforcing applicable rules adopted
- 16 by DOT and DPS.
- 17 The bill requires DPS to adopt rules relating to (1) the
- 18 enforcement of motor vehicle laws, including laws governing the
- 19 safe movement and operation of CMVs and vehicles transporting
- 20 loads and (2) rules regarding enforcement of rules for
- 21 transportation of hazardous materials. DPS is required to
- 22 submit a report annually to the general assembly detailing the
- 23 nature and scope of enforcement activities relating to CMVs.
- 24 DPS is also required to submit a report to the general assembly
- 25 on or before December 1, 2023, regarding the progress of the
- 26 transitions and transfers required in the bill.
- 27 Under current law, MVE officers are authorized to enforce
- 28 federal motor carrier safety rules adopted by DOT. Pursuant to
- 29 such authorization, MVE officers may enter a motor carrier's
- 30 place of business for the purpose of performing a motor carrier
- 31 safety audit or compliance review. An MVE officer is also
- 32 authorized to inspect and copy motor carrier records required
- 33 by federal law. The bill authorizes DPS peace officers to
- 34 perform a safety audit or compliance review or inspect motor
- 35 carrier records.

      RETIREMENT AND LONGEVITY PAY. DOT employees are members
 2 of, and receive benefits from, the Iowa public employees'
 3 retirement system (IPERS) (Code chapter 97B). DPS officers
 4 are members of, and receive benefits from, the peace officers'
 5 retirement, accident, and disability system (Code chapter 97A).
 6 Under the bill, a transferred MVE officer who has 10 or more
 7 years of membership service in IPERS on July 1, 2023, will
 8 remain a member of IPERS and will continue to be considered
 9 an employee in a protection occupation.
                                           A transferred MVE
10 officer who has fewer than 10 years of membership service in
11 IPERS will become a member of the peace officers' retirement,
12 accident, and disability system. A person who is employed
