A BILL FOR

- 1 An Act requiring notice to the general assembly in actions
- 2 regarding the constitutionality of a statute and including
- 3 effective date and applicability provisions.
- 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. NEW SECTION. 613.22 Challenges to
- 2 constitutionality of statutes notice to general assembly.
- 3 A party that files a pleading, motion, or petition
- 4 challenging the constitutionality of a statute shall do all of
- 5 the following:
- 6 l. File a notice of constitutional question stating the
- 7 question and identifying the pleading, motion, or petition that
- 8 raises the challenge to the constitutionality of the statute.
- 9 2. Serve the notice and copy of the pleading, motion, or
- 10 petition on the general assembly by the chief clerk of the
- 11 house and the secretary of the senate by restricted certified
- 12 mail or by personal service at the time the pleading, motion,
- 13 or petition is filed.
- 14 Sec. 2. NEW SECTION. 625A.7 Challenges to constitutionality
- 15 of statutes notice to general assembly.
- 16 In an action that challenges the constitutionality of a
- 17 statute, the appellant shall do all of the following:
- 18 1. File a notice of constitutional question stating the
- 19 question and identifying the pleading, motion, or petition that
- 20 raises the challenge to the constitutionality of the statute.
- 21 2. Serve notice and a copy of the pleading, motion, or
- 22 petition that raises the challenge to the constituent of the
- 23 statute upon the general assembly by the chief clerk of the
- 24 house and the secretary of the senate by personal service or
- 25 by restricted certified mail at the time of application for
- 26 interlocutory appeal or notice of appeal is filed.
- 27 Sec. 3. EFFECTIVE DATE. This Act, being deemed of immediate
- 28 importance, takes effect upon enactment.
- 29 Sec. 4. APPLICABILITY. This Act applies to petitions and
- 30 appeals filed on or after the effective date of this Act.
- 31 EXPLANATION
- 32 The inclusion of this explanation does not constitute agreement with
- 33 the explanation's substance by the members of the general assembly.
- 34 This bill requires service of notice on the general assembly
- 35 for actions regarding the constitutionality of a statute

- 1 enacted by the general assembly.
- 2 The bill provides that in a district court action
- 3 challenging the constitutionality of a statute, the party
- 4 bringing the constitutionality of the statute into question
- 5 is required to serve a copy of original notice and a copy of
- 6 the motion, pleading, or petition to the general assembly by
- 7 the chief clerk of the house or the secretary of the senate
- 8 by either restricted certified mail or personal service. The
- 9 bill also requires notice to be served to the general assembly
- 10 in actions challenging the constitutionality of a statute on
- 11 appeal.
