A domestic mutual insurance company, upon approval 4 of the commissioner, may reorganize by forming an insurance 5 holding company based upon a mutual plan and continuing the 6 corporate existence of the reorganizing insurance company as 7 a stock insurance company. The reorganized insurance company 8 may continue to use the word "mutual" in the company's name 9 provided that the company's name also includes the words "stock 10 insurer", or the abbreviation "SI". The commissioner, after 11 a public hearing as provided in section 521A.3, subsection 12 4, paragraph "b", if satisfied that the interests of the 13 policyholders are properly protected and that the plan of 14 reorganization is fair and equitable to the policyholders, may 15 approve the proposed plan of reorganization and may require 16 as a condition of approval such modifications of the proposed 17 plan of reorganization as the commissioner finds necessary 18 for the protection of the policyholders' interests. 19 commissioner may retain consultants as provided in section 20 521A.3, subsection 4, paragraph "d".
