- 9 center for agricultural safety and health, which is part of
- 10 UI's college of public health.
- 11 DALS, DNR, AND UI EFF GENERAL APPROPRIATIONS. The
- 12 bill appropriates moneys from the EFF to support a number of
- 13 programs administered by DALS, DNR, and UI. For DALS, the
- 14 moneys are appropriated to support programs involving soil
- 15 conservation, watershed protection and nutrient management,
- 16 and the loess hills development and conservation fund. For
- 17 DNR, moneys are appropriated to support programs involving
- 18 state parks, geographic information systems, water quality
- 19 monitoring, public water supplies, regulation of animal feeding
- 20 operations, air quality, and floodplain management and dam
- 21 safety. For UI, moneys are appropriated to support the Iowa
- 22 geological survey. The bill includes provisions that delay the
- 23 reversion of these moneys.
- 24 EFF SPECIAL APPROPRIATIONS FOR WQIF. The bill
- 25 appropriates moneys from the EFF to the WQIF subject to certain
- 26 conditions.
- 27 REAP FUND EFF APPROPRIATION IN LIEU OF GF APPROPRIATION.
- 28 The bill appropriates moneys from the EFF to the REAP
- 29 fund instead of the \$20 million otherwise required to be
- 30 appropriated to the REAP fund from the GF. Notwithstanding
- 31 the standing allocation from the REAP fund to its open
- 32 spaces account, DNR may use moneys in the account for state
- 33 park maintenance, development, operations, and facility
- 34 refurbishment.
