**A BILL FOR**

1 An Act establishing a scenic byways enhancement fund, including  
2 by providing for voluntary contributions to the fund, making  
3 appropriations, and including effective date provisions.  
4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. NEW SECTION. **307.50 Scenic byways enhancement**  
2 **fund.**

3 1. A scenic byways enhancement fund is created in the state  
4 treasury under the control of the department. The fund shall  
5 consist of moneys transferred to the fund pursuant to section  
6 321.44B and any other moneys appropriated to or deposited in the  
7 fund. Moneys in the fund are appropriated to the department for  
8 the support, development, maintenance, and enhancement, including  
9 but not limited to litter prevention, of the scenic byways of  
10 this state.

11 2. Notwithstanding section 8.33, moneys in the fund that  
12 remain unencumbered or unobligated at the close of a fiscal  
13 year shall not revert but shall remain available for expenditure  
14 for the purposes designated. Notwithstanding section 12C.7,  
15 subsection 2, interest or earnings on moneys in the fund shall  
16 be credited to the fund.

17 Sec. 2. NEW SECTION. **321.44B Voluntary contribution —**  
18 **scenic byways enhancement fund — amount retained by county**  
19 **treasurer.**

20 For each application for vehicle registration renewal, the  
21 county treasurer or the department shall request through use  
22 of a written form, and, if the application is made in person,  
23 through verbal communication, that an applicant make a voluntary  
24 contribution of one dollar or more, computed to the nearest whole  
25 dollar, to the scenic byways enhancement fund established in  
26 section 307.50. One hundred percent of the moneys collected by  
27 the county and one hundred percent of the moneys collected by  
28 the department in the form of contributions shall be remitted  
29 to the treasurer of state for deposit in the scenic byways  
30 enhancement fund to be used for the purposes specified for the  
31 fund. However, up to five percent of the moneys collected by  
32 the county may be retained by the county treasurer for deposit in  
33 the general fund of the county. The department shall adopt rules  
34 pursuant to chapter 17A to administer this section.

35 Sec. 3. Section 331.557, subsection 1, Code 2025, is amended

1 to read as follows:

2 1. Issue, renew, and replace lost or damaged vehicle  
 3 registration cards or plates and issue and transfer certificates  
 4 of title for vehicles, and collect voluntary contributions,  
 5 as provided in sections 321.17 through 321.20B, 321.22 through  
 6 321.26, 321.28 through 321.32, 321.34, 321.35, and 321.37 through  
 7 321.52.

8 Sec. 4. EFFECTIVE DATE. This Act takes effect January 1,  
 9 2026.

#### 10 EXPLANATION

11 The inclusion of this explanation does not constitute agreement with  
 12 the explanation's substance by the members of the general assembly.

13 This bill creates a scenic byways enhancement fund and  
 14 appropriates moneys in the fund to the department of  
 15 transportation (DOT) for the support, development, maintenance,  
 16 and enhancement, including litter prevention, of scenic byways.  
 17 For each application to renew the registration of a vehicle,  
 18 the county treasurer or the DOT is required to request that an  
 19 applicant make a voluntary contribution of \$1 or more, computed  
 20 to the nearest whole dollar, to the scenic byways enhancement  
 21 fund. Up to 5 percent of the moneys collected by the county may  
 22 be retained by the county treasurer for deposit in the general  
 23 fund of the county.

24 The bill takes effect January 1, 2026.
