A BILL FOR

- 1 An Act relating to persons eligible for special registration
- 2 plates with a veteran processed emblem.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section 321.34, subsection 27, paragraph a, Code
2 2025, is amended to read as follows:

3 a. An owner referred to in subsection 12 who served in
4 the armed forces or reserve forces of the United States or
5 the Iowa national guard, regardless of the number of years
6 of service, and was discharged under honorable conditions may,
7 upon written application to the department and upon presentation
8 of satisfactory proof of ~~military~~ service and discharge under
9 honorable conditions, order special registration plates bearing
10 a distinguishing processed emblem depicting the word "veteran"
11 below an image of the American flag. The application is
12 subject to approval by the department. The special plate fees
13 collected by the director under subsection 12, paragraph "a",
14 from the annual validation of letter-number designated United
15 States veteran plates, and subsection 12, paragraph "c", from
16 the issuance and annual validation of personalized United States
17 veteran plates, shall be paid monthly to the treasurer of state
18 and deposited in the road use tax fund. The treasurer of
19 state shall transfer monthly from the statutory allocations fund
20 created under section 321.145, subsection 2, to the veterans
21 license fee fund created in section 35A.11 the amount of the
22 special fees collected under subsection 12, paragraph "a", in the
23 previous month for United States veteran plates.

24 EXPLANATION

25 The inclusion of this explanation does not constitute agreement with
26 the explanation's substance by the members of the general assembly.

27 Under current law, the department of transportation (DOT)
28 is authorized to issue special registration plates with a
29 distinguishing processed emblem depicting the word "veteran"
30 below an image of the American flag to a motor vehicle owner
31 who served in the armed forces of the United States and
32 was discharged under honorable conditions. Pursuant to rules
33 adopted by the DOT (761 IAC 401.31), an application for special
34 plates with a veteran processed emblem must be submitted to
35 the commission of veterans affairs on a form prescribed by the

1 DOT. The commission of veterans affairs must determine whether
2 the applicant is a veteran and, if so, certify this fact on the
3 application form.

4 This bill makes persons who served in the reserve forces of
5 the United States or the Iowa national guard, regardless of
6 the number of years of service, and who were discharged under
7 honorable conditions eligible to receive special registration
8 plates with a veteran processed emblem.

9 Under current law, "veteran", when used in Code chapter
10 35 (veterans affairs), and in numerous other provisions by
11 reference, includes former members of the reserve forces of the
12 United States or the Iowa national guard who served at least 20
13 years and who were discharged under honorable conditions; members
14 of the reserve forces of the United States or the Iowa national
15 guard who were activated for federal duty, other than training,
16 for a minimum aggregate of 90 days, and were discharged under
17 honorable conditions or were retired in accordance with federal
18 law; and members of the reserve forces of the United States or
19 the Iowa national guard who have served at least 20 years and who
20 continue to serve.
