A BILL FOR

1 An Act relating to controlled substances schedules and
2 precursor substances reporting requirements, making penalties
3 applicable, and including effective date provisions.
4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section 124.204, subsection 2, Code 2026, is
2 amended by adding the following new paragraphs:

3 NEW PARAGRAPH. *dd.* 2-(2-(4-butoxybenzyl)-5-nitro-
4 1H-benzimidazol-1-yl)-N,N-diethylethan-1-amine. Other name:
5 Butonitazene.

6 NEW PARAGRAPH. *de.* N,N-diethyl-2-(2-(4-fluorobenzyl)-
7 5-nitro-1H-benzimidazol-1-yl)ethan-1-amine. Other name:
8 Flunitazene.

9 NEW PARAGRAPH. *df.* N,N-diethyl-2-(2-(4-
10 methoxybenzyl)-1H-benzimidazol-1-yl)ethan-1-amine. Other name:
11 Metodesnitazene.

12 NEW PARAGRAPH. *dg.* N-phenyl-N-(1-(2-
13 phenylpropyl)piperidin-4-yl)acetamide. Other name:
14 beta-methylacetyl fentanyl.

15 NEW PARAGRAPH. *dh.* N-(3-fluorophenyl)-N-(1-
16 phenethylpiperidin-4-yl)furan-20carboxamide. Other name:
17 meta-fluorofuranyl fentanyl.

18 NEW PARAGRAPH. *di.* N-(2-chlorophenyl)-N-(1-
19 phenethylpiperidin-4-yl)propionamide. Other name:
20 ortho-chlorofentanyl.

21 NEW PARAGRAPH. *dj.* N-(2-methylphenyl)-N-(1-
22 phenethylpiperidin-4-yl)cyclopropanecarboxamide. Other name:
23 ortho-methylcyclopropyl fentanyl.

24 NEW PARAGRAPH. *dk.* N-(4-chlorophenyl)-N-(1-
25 phenethylpiperidin-4-yl)propionamide. Other name:
26 para-chlorofentanyl.

27 NEW PARAGRAPH. *dl.* N-(4-fluorophenyl)-N-(1-
28 phenethylpiperidin-4-yl)pentanamide. Other name: para-fluoro
29 valeryl fentanyl.

30 NEW PARAGRAPH. *dm.* N-(1-phenethylpiperidin-4-yl)-
31 N-phenyltetrahydrothiophene-2-carboxamide. Other names:
32 tetrahydrothiofuranyl fentanyl; tetrahydrothiophene fentanyl.

33 Sec. 2. Section 124.204, subsection 4, Code 2026, is amended
34 by adding the following new paragraph:

35 NEW PARAGRAPH. *cq.* 1-(1,3-benzodioxol-5-yl)-2-

1 (dimethylamino)pentan-1-one. Other names: dipentylone;
2 N,N-dimethylpentylone.

3 Sec. 3. Section 124.204, subsection 6, Code 2026, is amended
4 by adding the following new paragraph:

5 NEW PARAGRAPH. m. ethyl 2-phenyl-2-(piperidin-2-yl)acetate.
6 Other name: ethylphenidate.

7 Sec. 4. Section 124.204, subsection 9, Code 2026, is amended
8 by adding the following new paragraphs:

9 NEW PARAGRAPH. w. 2-(4-methoxybenzyl)-5-nitro-1-(2-
10 (pyrrolidin-1-yl)ethyl)-1H-benzimidazole, its isomers, esters,
11 ethers, salts, and salts of isomers, esters, and ethers. Other
12 names: N-pyrrolidino metonitazene; metonitazepyne.

13 NEW PARAGRAPH. x. 5-nitro-2-(4-propoxybenzyl)-1-(2-
14 (pyrrolidin-1-yl)ethyl)-1H-benzimidazole, its isomers, esters,
15 ethers, salts, and salts of isomers, esters, and ethers. Other
16 names: N-pyrrolidino protonitazene; protonitazepyne.

17 Sec. 5. Section 124.204, subsection 9, paragraphs c, e, and
18 f, Code 2026, are amended by striking the paragraphs.

19 Sec. 6. EFFECTIVE DATE. This Act, being deemed of immediate
20 importance, takes effect upon enactment.

21 EXPLANATION

22 The inclusion of this explanation does not constitute agreement with
23 the explanation's substance by the members of the general assembly.

24 This bill relates to controlled substances, including certain
25 controlled substances schedules.

26 The bill makes changes to the controlled substances schedule I
27 in Iowa's uniform controlled substances Act (Code chapter 124) to
28 conform to the specific chemical designations of the substances
29 contained in Title 21 of the Code of Federal Regulations, part
30 1308.

31 A violation involving a controlled substance included in the
32 bill may result in a class "B" felony, and in addition to the
33 25-year mandatory minimum term of imprisonment for class "B"
34 felons, a fine of not less than \$5,000 nor more than \$100,000;
35 a class "C" felony punishable by imprisonment up to 10 years

1 and a fine of not less than \$1,000 nor more than \$50,000; or an
2 aggravated misdemeanor punishable by imprisonment up to 2 years
3 and a fine of at least \$855 but not more than \$8,540.
4 The bill takes effect upon enactment.
