Section 103A.19, unnumbered paragraph 1, Code 8 2007, is amended to read as follows: 1 1 The examination and approval or disapproval of plans and 1 1 10 specifications, the issuance and revocation of building 11 permits, licenses, certificates, and similar documents, the 1 12 inspection of buildings or structures, and the administration 1 13 and enforcement of building regulations shall be the 1 14 responsibility of the governmental subdivisions of the state 1 15 and shall be administered and enforced in the manner 1 16 prescribed by local law or ordinance. All provisions of law 1 17 relating to the administration and enforcement of local 1 18 building regulations in any governmental subdivision shall be 1 19 applicable to the administration and enforcement of the state 1 20 building code in the governmental subdivision. An application 1 21 made to a local building department or to a state agency for 22 permission to construct a building or structure pursuant to 23 the provisions of the state building code shall, in addition 1 1 24 to any other requirement, be signed by the owner or the 25 owner's authorized agent, and shall contain the address of the 26 owner, and a statement that the application is made for 1 1 1 27 permission to construct in accordance with the provisions of 28 the code. The application shall also specifically include a that the construction will be in accordance with all statement 30 applicable energy conservation requirements.
31 Sec. 3. Section 103A.19, Code 2007, is amended by adding 1 31 32 the following new unnumbered paragraph: 1 33 NEW UNNUMBERED PARAGRAPH. On or before December 31, 2008, 1 34 each governmental subdivision of the state shall report to the 35 commissioner on the status of the governmental subdivision's 1 efforts to enforce applicable energy conservation 1 2 requirements, including a statement of whether the 3 requirements are being enforced within the jurisdiction, the 4 number of staff who are trained to enforce the requirements, 5 and the number of buildings and structures that have been 6 found not to comply with the requirements during the routine 7 inspection of buildings and structures conducted since July 1,
