A BILL FOR

- 1 An Act relating to the licensure of orthotists, prosthetists,
- 2 and pedorthists and providing for fees and penalties.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 147.1, subsections 3 and 6, Code 2011, 2 are amended to read as follows:
- 3. "Licensed" or "certified", when applied to a physician
- 4 and surgeon, podiatric physician, osteopathic physician and
- 5 surgeon, physician assistant, psychologist, chiropractor,
- 6 nurse, dentist, dental hygienist, dental assistant,
- 7 optometrist, speech pathologist, audiologist, pharmacist,
- 8 physical therapist, physical therapist assistant, occupational
- 9 therapist, occupational therapy assistant, orthotist,
- 10 prosthetist, pedorthist, respiratory care practitioner,
- 11 practitioner of cosmetology arts and sciences, practitioner
- 12 of barbering, funeral director, dietitian, marital and
- 13 family therapist, mental health counselor, social worker,
- 14 massage therapist, athletic trainer, acupuncturist, nursing
- 15 home administrator, hearing aid dispenser, or sign language
- 16 interpreter or transliterator means a person licensed under
- 17 this subtitle.
- 18 6. "Profession" means medicine and surgery, podiatry,
- 19 osteopathic medicine and surgery, practice as a physician
- 20 assistant, psychology, chiropractic, nursing, dentistry,
- 21 dental hygiene, dental assisting, optometry, speech pathology,
- 22 audiology, pharmacy, physical therapy, physical therapist
- 23 assisting, occupational therapy, occupational therapy
- 24 assisting, respiratory care, cosmetology arts and sciences,
- 25 barbering, mortuary science, marital and family therapy, mental
- 26 health counseling, social work, dietetics, massage therapy,
- 27 athletic training, acupuncture, nursing home administration,
- 28 hearing aid dispensing, or sign language interpreting or
- 29 transliterating, orthotics, prosthetics, or pedorthics.
- 30 Sec. 2. Section 147.2, subsection 1, Code 2011, is amended
- 31 to read as follows:
- 32 1. A person shall not engage in the practice of medicine
- 33 and surgery, podiatry, osteopathic medicine and surgery,
- 34 psychology, chiropractic, physical therapy, physical
- 35 therapist assisting, nursing, dentistry, dental hygiene,

- 1 dental assisting, optometry, speech pathology, audiology,
- 2 occupational therapy, occupational therapy assisting,
- 3 orthotics, prosthetics, pedorthics, respiratory care,
- 4 pharmacy, cosmetology arts and sciences, barbering, social
- 5 work, dietetics, marital and family therapy or mental health
- 6 counseling, massage therapy, mortuary science, athletic
- 7 training, acupuncture, nursing home administration, hearing aid
- 8 dispensing, or sign language interpreting or transliterating,
- 9 or shall not practice as a physician assistant, unless the
- 10 person has obtained a license for that purpose from the board
- 11 for the profession.
- 12 Sec. 3. Section 147.13, Code 2011, is amended by adding the
- 13 following new subsection:
- 14 NEW SUBSECTION. 24. For orthotics, prosthetics, and
- 15 pedorthics, the board of podiatry.
- 16 Sec. 4. Section 147.14, subsection 1, paragraph s, Code
- 17 2011, is amended to read as follows:
- 18 s. For podiatry, five members licensed to practice podiatry,
- 19 two members licensed to practice orthotics, prosthetics, or
- 20 pedorthics, and two members who are not so licensed to practice
- 21 podiatry and who shall represent the general public.
- Sec. 5. Section 147.74, Code 2011, is amended by adding the
- 23 following new subsection:
- 24 NEW SUBSECTION. 24. a. An orthotist licensed under chapter
- 25 148F may use the words "licensed orthotist" after the person's
- 26 name or signify the same by the use of the letters "L.O." after
- 27 the person's name.
- 28 b. A pedorthist licensed under chapter 148F may use the
- 29 words "licensed pedorthist" after the person's name or signify
- 30 the same by the use of the letters "L.ped." after the person's
- 31 name.
- 32 c. A prosthetist licensed under chapter 148F may use the
- 33 words "licensed prosthetist" after the person's name or signify
- 34 the same by the use of the letters "L.P." after the person's
- 35 name.

- 1 Sec. 6. NEW SECTION. 148F.1 Title and purpose.
- This chapter may be cited and referred to as the
- 3 "Orthotics, Prosthetics, and Pedorthics Practice Act".
- 4 2. The purpose of this chapter is to provide for the
- 5 regulation of persons offering orthotic, prosthetic, and
- 6 pedorthic services to the public in order to safeguard the
- 7 public health, safety, and welfare.
- 8 Sec. 7. NEW SECTION. 148F.2 Definitions.
- 9 As used in this chapter:
- 10 1. "Board" means the board of podiatry.
- 11 2. "Orthosis" means a custom-fabricated or custom-fitted
- 12 brace or support designed to provide for alignment, correction,
- 13 or prevention of neuromuscular or musculoskeletal dysfunction,
- 14 disease, injury, or deformity. "Orthosis" does not include
- 15 fabric or elastic supports, corsets, arch supports, low
- 16 temperature plastic splints, trusses, elastic hoses, canes,
- 17 crutches, soft cervical collars, dental appliances, or other
- 18 similar devices carried in stock and sold as "over-the-counter"
- 19 items by a drug store, department store, corset shop, or
- 20 surgical supply facility.
- 21 3. "Orthotic and prosthetic education program" means a
- 22 course of instruction accredited by the national commission on
- 23 accreditation of allied health education programs, consisting
- 24 of both of the following:
- 25 a. A basic curriculum of college level instruction in math,
- 26 physics, biology, chemistry, and psychology.
- 27 b. A specific curriculum in orthotic or prosthetic courses,
- 28 including but not limited to:
- 29 (1) Lectures covering pertinent anatomy, biomechanics,
- 30 pathomechanics, prosthetic-orthotic components and materials,
- 31 training and functional capabilities, prosthetic or orthotic
- 32 performance evaluation, prescription considerations, etiology
- 33 of amputations and disease processes necessitating prosthetic
- 34 or orthotic use, and medical management.
- 35 (2) Subject matter related to pediatric and geriatric

1 problems.

- 2 (3) Instruction in acute care techniques, such as immediate 3 and early post-surgical prosthetics and fracture bracing 4 techniques.
- 5 (4) Lectures, demonstrations, and laboratory experiences 6 related to the entire process of measuring, casting, fitting, 7 fabricating, aligning, and completing prostheses or orthoses.
- 9 list of tasks, with relative weight given to such factors as
 10 importance, criticality, and frequency, based on nationally
 11 accepted standards of orthotic and prosthetic care as
 12 outlined by the American board for certification in orthotics,
 13 prosthetics, and pedorthics.

4. "Orthotic and prosthetic scope of practice" means a

- 5. "Orthotics" means the science and practice of evaluating, measuring, designing, fabricating, assembling, fitting, adjusting, or servicing an orthosis under an order from a licensed physician or podiatric physician for the correction or alleviation of neuromuscular or musculoskeletal dysfunction, disease, injury, or deformity.
- 20 6. "Orthotist" means a health care professional,
 21 specifically educated and trained in orthotic patient care,
 22 who measures, designs, fabricates, fits, or services orthoses
 23 and may assist in the formulation of the order and treatment
 24 plan of orthoses for the support or correction of disabilities
 25 caused by neuromusculoskeletal diseases, injuries, or
 26 deformities.
- 7. "Pedorthic device" means therapeutic shoes, such as diabetic shoes and inserts, shoe modifications made for therapeutic purposes, below-the-ankle partial foot prostheses, and foot orthoses for use at the ankle or below. The term also includes subtalar-control foot orthoses designed to manage the function of the anatomy by controlling the range of motion of the subtalar joint. Excluding pedorthic devices which are footwear, the proximal height of a custom pedorthic device does not extend beyond the junction of the gastrocnemius and

- 1 the Achilles tendon. "Pedorthic device" does not include
- 2 nontherapeutic inlays or footwear regardless of method of
- 3 manufacture; unmodified, nontherapeutic over-the-counter shoes;
- 4 or prefabricated foot care products.
- 5 8. "Pedorthic education program" means an educational
- 6 program accredited by the American board for certification in
- 7 orthotics, prosthetics, and pedorthics consisting of all of the
- 8 following:
- 9 a. A basic curriculum of instruction in foot-related
- 10 pathology of diseases, anatomy, and biomechanics.
- ll b. A specific curriculum in pedorthic courses, including
- 12 lectures covering shoes, foot orthoses, and shoe modifications,
- 13 pedorthic components and materials, training and functional
- 14 capabilities, pedorthic performance evaluation, prescription
- 15 considerations, etiology of disease processes necessitating
- 16 use of pedorthic devices, medical management, subject matter
- 17 related to pediatric and geriatric problems, and lectures,
- 18 demonstrations, and laboratory experiences related to the
- 19 entire process of measuring and casting, fitting, fabricating,
- 20 aligning, and completing pedorthic devices.
- 21 9. "Pedorthic scope of practice" means a list of tasks
- 22 with relative weight given to such factors as importance,
- 23 criticality, and frequency based on nationally accepted
- 24 standards of pedorthic care as outlined by the American board
- 25 for certification in orthotics, prosthetics and pedorthics.
- 26 10. "Pedorthics" means the science and practice of
- 27 evaluating, measuring, designing, fabricating, assembling,
- 28 fitting, adjusting, or servicing a pedorthic device under an
- 29 order from a licensed physician or podiatric physician for the
- 30 correction or alleviation of neuromuscular or musculoskeletal
- 31 dysfunction, disease, injury, or deformity.
- 32 11. "Pedorthist" means a health care professional,
- 33 specifically educated and trained in pedorthic patient
- 34 care, who measures, designs, fabricates, fits, or services
- 35 pedorthic devices and may assist in the formulation of the

- 1 order and treatment plan of pedorthic devices for the support
- 2 or correction of disabilities caused by neuromusculoskeletal
- 3 diseases, injuries, or deformities.
- 4 12. "Prosthesis" means an artificial medical device that
- 5 is not surgically implanted and that is used to replace a
- 6 missing limb, appendage, or any other external human body part
- 7 including an artificial limb, hand, or foot.
- 8 13. "Prosthetics" means the science and practice of
- 9 evaluating, measuring, designing, fabricating, assembling,
- 10 fitting, adjusting, or servicing a prosthesis under an order
- 11 from a licensed physician.
- 12 14. "Prosthetist" means a health care professional,
- 13 specifically educated and trained in prosthetic patient care,
- 14 who measures, designs, fabricates, fits, or services prostheses
- 15 and may assist in the formulation of the order and treatment
- 16 plan of prostheses for the replacement of external parts of the
- 17 human body lost due to amputation or congenital deformities or
- 18 absences.
- 19 15. "Resident" means a person who has completed an education
- 20 program in either orthotics or prosthetics and is continuing
- 21 the person's clinical education in a residency accredited by
- 22 the American board for certification in orthotics, prosthetics
- 23 and pedorthics.
- 24 16. "Residency" means an approved supervised program of
- 25 a minimum duration of one year to acquire practical clinical
- 26 training in orthotics or prosthetics in a patient care setting.
- 27 Sec. 8. NEW SECTION. 148F.3 Duties of the board.
- 28 The board shall administer this chapter. The board's duties
- 29 shall include but are not limited to the following:
- 30 1. Adoption of rules to administer and interpret this
- 31 chapter, chapter 147, and chapter 272C with respect to the
- 32 education and licensing of orthotists, prosthetists, and
- 33 pedorthists.
- 34 2. Adoption of rules to establish accepted standards of
- 35 orthotic and prosthetic scope of practice, including the

- 1 classification of devices and supervision of nonlicensed
 2 caregivers.
- Adoption of rules relating to professional conduct and
- 4 licensing and the establishment of ethical and professional
- 5 standards of practice.
- 6 4. Acting on matters concerning licensure and the process
- 7 of applying for, granting, suspending, imposing supervisory
- 8 or probationary conditions upon, reinstating, revoking, or
- 9 renewing a license.
- 10 5. Establishing and collecting licensure fees as provided
- 11 in section 147.80.
- 12 6. Developing continuing education requirements as a
- 13 condition of license renewal.
- 7. Evaluating requirements for licensure in other states to
- 15 determine if reciprocity may be granted.
- 16 8. Adoption of rules providing temporary licensing for
- 17 persons providing orthotic, prosthetic, and pedorthic care
- 18 in this state prior to the effective date of this Act. A
- 19 temporary license is good for no more than one year.
- 20 Sec. 9. NEW SECTION. 148F.4 Persons and practices not
- 21 affected.
- 22 This chapter does not prevent or restrict the practice,
- 23 services, or activities of any of the following:
- 24 1. A person licensed in this state by any other law from
- 25 engaging in the profession or occupation for which the person
- 26 is licensed, including but not limited to persons set out in
- 27 section 147.1, subsections 3 and 6.
- 28 2. A person employed as an orthotics, prosthetics, or
- 29 pedorthics practitioner by the government of the United States
- 30 if that person practices solely under the direction or control
- 31 of the organization by which the person is employed.
- 32 3. A person pursuing a course of study leading to a degree
- 33 or certificate in orthotics, prosthetics, or pedorthics in an
- 34 educational program accredited or approved according to rules
- 35 adopted by the board, if the activities and services constitute

- 1 a part of a supervised course of study and the person is
- 2 designated by a title which clearly indicates the person's
- 3 status as a student, resident, or trainee.
- 4 Sec. 10. NEW SECTION. 148F.5 Qualifications for licensure
- 5 as orthotist, prosthetist, or pedorthist.
- 6 l. To qualify for a license to practice orthotics or
- 7 prosthetics, a person shall meet the following requirements:
- 8 a. Possess a baccalaureate degree from a college or
- 9 university.
- 10 b. Have completed the amount of formal training, including
- 11 but not limited to an orthotic and prosthetic education
- 12 program, and clinical practice established and approved by the
- 13 board.
- 14 c. Complete a clinical residency in the professional area
- 15 for which a license is sought in accordance with standards,
- 16 quidelines, or procedures for residencies established and
- 17 approved by the board. The majority of training must be
- 18 devoted to services performed under the supervision of a
- 19 licensed practitioner of orthotics or prosthetics or a person
- 20 certified as a certified orthotist, certified prosthetist,
- 21 or certified prosthetist orthotist whose practice is located
- 22 outside the state.
- 23 d. Pass all written, practical, and oral examinations that
- 24 are required and approved by the board.
- 25 e. Be qualified to practice in accordance with accepted
- 26 standards of orthotic and prosthetic care as established by the
- 27 board.
- 28 2. To qualify for a license to practice pedorthics, a person
- 29 shall meet the following requirements:
- 30 a. Submit proof of a high school diploma or its equivalent.
- 31 b. Have completed the amount of formal training, including
- 32 but not limited to a pedorthic education program, and clinical
- 33 practice established and approved by the board.
- c. Complete a qualified work experience program or
- 35 internship in pedorthics that has a minimum of one thousand

- 1 hours of pedorthic patient care experience in accordance
- 2 with any standards, guidelines, or procedures established
- 3 and approved by the board. The majority of training must
- 4 be devoted to services performed under the supervision of a
- 5 licensed practitioner of pedorthics or a person certified as
- 6 a certified pedorthist whose practice is located outside the 7 state.
- 8 d. Pass all examinations that are required and approved by 9 the board.
- 10 e. Be qualified to practice in accordance with accepted 11 standards of pedorthic care as established by the board.
- 12 3. The standards and requirements for licensure established
- 13 by the board shall be substantially equal to or in excess of
- 14 standards commonly accepted in the professions of orthotics,
- 15 prosthetics, or pedorthics, as applicable. The board shall
- 16 adopt rules as necessary to set the standards and requirements.
- 17 4. A person may be licensed in more than one discipline.
- 18 Sec. 11. NEW SECTION. 148F.6 Assistants and technicians.
- 19 1. a. A person shall not work as an assistant to an
- 20 orthotist or prosthetist or provide patient care services or
- 21 fabrication of orthoses or prostheses, unless the work is
- 22 performed under the supervision of a licensed orthotist or
- 23 prosthetist.
- 24 b. An assistant may perform orthotic or prosthetic
- 25 procedures and related tasks in the management of patient care.
- 26 An assistant may also fabricate, repair, and maintain orthoses
- 27 and prostheses.
- 28 2. A technician may assist a person licensed under this
- 29 chapter with fabrication of orthoses, prostheses, or pedorthic
- 30 devices but shall not provide direct patient care.
- 31 Sec. 12. NEW SECTION. 148F.7 Limitation on provision of
- 32 care and services.
- 33 A licensed orthotist, prosthetist, or pedorthist may provide
- 34 care or services only if the care or services are provided
- 35 pursuant to an order from a licensed physician, a licensed

- 1 podiatric physician, an advanced registered nurse practitioner
- 2 who has a written collaborative agreement with a collaborating
- 3 physician or podiatric physician that specifically authorizes
- 4 ordering the services of an orthotist, prosthetist, or
- 5 pedorthist, an advanced registered nurse practitioner who
- 6 practices in a hospital or ambulatory surgical treatment center
- 7 and possesses clinical privileges to order services of an
- 8 orthotist, prosthetist, or pedorthist, or a physician assistant
- 9 who has been delegated the authority to order the services of
- 10 an orthotist, prosthetist, or pedorthist by the assistant's
- ll supervising physician. A licensed podiatric physician or an
- 12 advanced registered nurse practitioner collaborating with a
- 13 podiatric physician may only order care or services concerning
- 14 the foot from a licensed pedorthist or orthotist.
- 15 Sec. 13. NEW SECTION. 148F.8 Penalties.
- 16 l. If any person, company, or other entity violates a
- 17 provision of this chapter, the attorney general may petition
- 18 for an order enjoining the violation or for an order enforcing
- 19 compliance with this chapter. Upon the filing of a verified
- 20 petition in court, the court may issue a temporary restraining
- 21 order, without notice or bond, and may preliminarily and
- 22 permanently enjoin the violation. If it is established
- 23 that the person, company, or other entity has violated or is
- 24 violating the injunction, the court may punish the offender
- 25 for contempt of court. Proceedings under this section shall
- 26 be in addition to, and not in lieu of, all other remedies and
- 27 penalties provided in this chapter.
- If a person practices as an orthotist, prosthetist,
- 29 or pedorthist or represents the person as such without being
- 30 licensed under the provisions of this chapter, then any other
- 31 licensed orthotist, pedorthist, or prosthetist, any interested
- 32 party, or any person injured by the person may petition for
- 33 relief as provided in subsection 1.
- 34 3. If a company or other entity holds itself out to provide
- 35 orthotic, prosthetic, or pedorthic services without having

1 an orthotist, prosthetist, or pedorthist licensed under the 2 provisions of this chapter on its staff to provide those 3 services, then any other licensed orthotist, prosthetist, 4 or pedorthist or any interested party or injured person may 5 petition for relief as provided in subsection 1. Sec. 14. FUNDING. There is appropriated from the general 7 fund of the state to the board of podiatry for the fiscal year 8 beginning July 1, 2011, and ending June 30, 2012, the following 9 amount, or so much thereof as is necessary, to be used for the 10 purposes designated: For salaries, support, maintenance, and miscellaneous 12 purposes related to the licensure of persons offering orthotic, 13 prosthetic, or pedorthic services: 40,000 14 Notwithstanding section 8.33, moneys appropriated in this 15 16 section that remain unencumbered or unobligated at the close of 17 the fiscal year shall not revert but shall remain available for

18 expenditure for the purposes designated until the close of the

19 succeeding fiscal year.
