

## FREDERICK D. AUGUSTINE

Mr. Speaker: Your committee, appointed to prepare a suitable resolution commemorating the life, character, and public service of the late Honorable Frederick Deforest Augustine, begs leave to submit the following memorial:

Mr. Augustine was born near Orient, Iowa, Adair County on August 21, 1887, where he grew to manhood. He graduated from Orient High School in 1906, attending Drake University afterward. He was united in marriage to Miss Jessie M. Wade in 1912 and moved to Benton, Iowa in 1913 where he was engaged in business. He was a lumber implement dealer at the time of his election. Later he moved to Des Moines and was a parole officer and agent for the Iowa Board of Parole.

He lived in Des Moines for fifty years and was a member of the Highland Park Christian Church, Auburn Masonic Lodge, Auburn Order of Eastern Star 499, and the Des Moines Consistory.

A Democrat, Mr. Augustine was elected and served as Representative from Ringgold County in the Forty-fourth, Forty-fifth and Forty-fifth Extra General Assemblies.

Mr. Augustine died July 25, 1982 in Des Moines, Iowa. He is survived by his wife, Jessie M.

RAYMOND BREAKENRIDGE

Mr. Speaker: Your committee, appointed to prepare a suitable resolution commemorating the life, character, and public service of the late Honorable Raymond Breakenridge, begs leave to submit the following memorial:

Raymond Breakenridge was born on August 17, 1897 to James and Helen Perkins Breakenridge, in Madison County, Iowa. On September 14, 1918 he married Vera Bowen of Chariton, Iowa. They had one daughter, Fern.

Mr. Breakenridge operated his own farm in Madison County which specialized in registered Shorthorn cattle. He was president of the county Shorthorn Breeder's Association, a member of the Farm Bureau, a member of the Farmer's Co-operative Association, a past member of the Farmer's Electric Co-operative Association and County Fair Association, served as a Farm Bureau township director and was an active member of the West Star Methodist Church near Winterset, Iowa.

A Republican, Raymond Breakenridge represented Madison County in the Iowa House during the Fifty-sixth and Fifty-seventh General Assemblies.

Mr. Breakenridge died on August 4, 1982 in Louisiana at the age of 84. He is survived by his wife, Vera, and his daughter, Fern, both of Natchitoches, Louisiana, along with two grandchildren.

DAVID A. DANCER

Mr. Speaker: Your committee, appointed to prepare a suitable resolution commemorating the life, character, and public service of the late Honorable David Anderson Dancer, begs leave to submit the following memorial:

Mr. Dancer was born at Lamoni, Iowa, Decatur County, on October 7, 1896. On November 17, 1917, he was united in marriage to Miss Florence Messerli, to which union were born three daughters.

He attended public schools at Lamoni, and served twenty-two months in the army, holding the commission of First Lieutenant. He was a charter member of the Ralph A. Judson post of American Legion at Lamoni, served on the Lamoni City Council for ten years, was a member of the board of directors of the Farmers Grain and Seed Company, was president of the Decatur Farm Bureau and was chairman of the board of the Lamoni Cooperative Creamery Association.

A 1917 graduate of the University of Iowa, he received the school's distinguished service award in 1964. He was a member of the alumni associations at the University of Iowa and Iowa State University. He was named secretary of the Regents, a position he held until 1968. He then served as director of alumni relations for the Des Moines College of Osteopathic Medicine and Surgery for two years. Dancer Hall, a dormitory at the University of Northern Iowa, is named for Mr. Dancer.
