W. Dean Aubrey was born in Munterville, Iowa, September 28, 1904, the son of Rosa and William Aubrey.

He attended William Penn College in Oskaloosa and served in the United States Marine Corps.

Mr. Aubrey is survived by his wife, Evelyn; three daughters, Mrs. Patricia Scott of Altoona, Mrs. Jean Shelley of Ankeny and Mrs. Sandra Grate of Des Moines; two sons, Gary of Des Moines and Michael of Norwalk.

He was a member of the Miner's Institute of America and the Altoona Methodist Church.

Mr. Aubrey, a Democrat, served in the House of Representatives in the Fifty-first, Fifty-third, Fifty-fourth and Fifty-eighth General Assemblies, representing Wapello County.

Mr. Aubrey passed away on October 20, 1975.

 CARROLL L. BROWN

MR. SPEAKER: Your committee, appointed to prepare a suitable resolution commemorating the life, character and public service of the late Honorable Carroll L. Brown, begs leave to submit the following memorial:

Carroll L. Brown was born in rural Mahaska County near Rose Hill, Iowa, on March 5, 1913, the son of Wirt and Lucy Lord Brown.

He attended elementary school and high school in Rose Hill, Iowa, and later attended Penn College in Oskaloosa, Iowa, from which he graduated in 1935, with a degree in education. He taught school for a period of five years before leaving that profession.

Mr. Brown married Ruby Hite on September 18, 1937. To this union were born three children: Marjorie Sue, Jeanne Ann, and Graigg.

Mr. Brown was a member of the Christian Church and the Tri-Luminar Masonic Lodge.

He was a sales supervisor for a seed corn company, owned and operated a grain and livestock farm, and was part owner and manager of a pig hatch-

ery. His interests were varied during his lifetime, with a distinct interest in agriculture.

Mr. Brown, a Republican, served Mahaska County as a representative in the Fifty-second, Fifty-second Extra, Fifty-third, Fifty-fourth, and Fifty-fifth General Assemblies. During his service in the General Assembly, he served as chairman of the Roads and Highways, Dairy and Food, and House Steering Committees.

Mr. Brown's sudden and untimely death occurred at Oskaloosa, Iowa, on April 12, 1976. He left to survive him his wife, a son, two daughters and sons-in-law, two grandsons, and a host of relatives, friends, and acquaintances.

*Therefore, Be It Resolved by the House of Representatives of the Sixty-sixth General Assembly of Iowa:* That in the passing of the late Honorable Carroll L. ### JAMES T. CAFFREY

MR. SPEAKER: Your committee, appointed to prepare a suitable resolution commemorating the life, character and public service of the late Honorable James T. Caffrey, begs leave to submit the following memorial:

James T. Caffrey was born in New York, New York, on February 19, 1909, and moved to Des Moines in February of 1943. He attended Xavier High School, graduated from Manhattan Prep, New York City, and attended Drake Community College for industrial relations courses.

Mr. Caffrey married Veronica Adrian in 1941. To this union were born two daughters, Veronica and Velda.

He was employed by Firestone Tire and Rubber Company from 1945 until his retirement in 1974. He was president of United Rubber Workers Union Local 310, vice-president of the South Central Iowa Federation of Labor, AFL-CIO, and a member of United Rubber Workers international executive board.

He was a member and trustee of St. Anthony's Church, a member of the Knights of Columbus Council 644, the Fourth Degree Knights of Columbus of Dowling General Assembly, and the Dowling Club. He was active in the Easter Seal Society, Des Moines Boys' Club, United Campaign and Future-of-Des Moines Committee.

Mr. Caffrey, a Democrat, served Polk County as a representative in the Sixty-first, Sixty-second, Sixty-third, Sixty-fifth and Sixty-sixth General Assemblies.
