Mr. Breakenridge operated his own farm in Madison County which specialized in registered Shorthorn cattle. He was president of the county Shorthorn Breeder's Association, a member of the Farm Bureau, a member of the Farmer's Co-operative Association, a past member of the Farmer's Electric Co-operative Association and County Fair Association, served as a Farm Bureau township director and was an active member of the West Star Methodist Church near Winterset, Iowa.

A Republican, Raymond Breakenridge represented Madison County in the Iowa House during the Fifty-sixth and Fifty-seventh General Assemblies.

Mr. Breakenridge died on August 4, 1982 in Louisiana at the age of 84. He is survived by his wife, Vera, and his daughter, Fern, both of Natchitoches, Louisiana, along with two grandchildren.

Mr. Speaker: Your committee, appointed to prepare a suitable resolution commemorating the life, character, and public service of the late Honorable David Anderson Dancer, begs leave to submit the following memorial:

Mr. Dancer was born at Lamoni, Iowa, Decatur County, on October 7, 1896. On November 17, 1917, he was united in marriage to Miss Florence Messerli, to which union were born three daughters.

He attended public schools at Lamoni, and served twenty two months in the army, holding the commission of First Lieutenant. He was a charter member of the Ralph A. Judson post of American Legion at Lamoni, served on the Lamoni City Council for ten years, was a member of the board of directors of the Farmers Grain and Seed Company, was president of the Decatur Farm Bureau and was chairman of the board of the Lamoni Cooperative Creamery Association.

A 1917 graduate of the University of Iowa, he received the school's distinguished service award in 1964. He was a member of the alumni associations at the University of Iowa and Iowa State University. He was named secretary of the Regents, a position he held until 1968. He then served as director of alumni relations for the Des Moines College of Osteopathic Medicine and Surgery for two years. Dancer Hall, a dormitory at the University of Northern Iowa, is named for Mr. Dancer.

A Republican, Mr. Dancer represented Decatur County in the Forty-sixth, Fortysixth Extra, Forty-seventh, Forty-eighth and Forty-ninth General Assemblies. He served as Speaker Pro Tempore in the Forty-ninth General Assembly.

EUGENE E. HALLING

Mr. Speaker: Your committee, appointed to prepare a suitable resolution commemorating the life, character, and public service of the late Honorable Eugene E. Halling, begs leave to submit the following memorial:

Eugene E. Halling was born May 20, 1895 in Orient, Iowa. On December 28, 1920, he was united in marriage to Margaret E. Shafar.

Mr. Halling was a graduate of Grinnell College and served in the United States Army during World War I. He served several years on the Hill of Zion Consolidated School Board. He was a deacon emeritus of the Hill of Zion Church and a charter member of the Orient American Legion and Greenfield Barracks 1533 of World War I. He farmed his family's farm in Adair County for about fifty-five years before retiring and moving into Creston in 1975.

A Republican, Mr. Halling represented Adair County in the Fifty-sixth, Fiftyseventh, Fifty-eighth, Fifty-ninth and Sixtieth General Assemblies. For twenty years he was a precinct committeeman for the Republican Party.

Eugene E. Halling died on February 18, 1982, at Creston, Iowa, at the age of 86. Survivors include his wife, Margaret, of Creston and a sister, Fern Johnston, of Huntington Beach, California. He was preceded in death by two sisters, Annabelle and Faye, and his parents, Mathias E. and Amanda Halling.
