

I. G. CHRYSTAL

MR. PRESIDENT: Your committee, appointed to prepare a suitable resolution commemorating the life, character and public service of the late Honorable I. G. Chrystal, begs leave to submit the following memorial:

I. G. Chrystal was born in Wapello County, Iowa, on September 27, 1885. Public school work, hotel business and farming were included among his occupations.

He was elected Senator from the forty-eighth Senatorial District of Iowa and served until 1939 during the Forty-fifth, Forty-fifth Extra, Forty-sixth and Forty-seventh General Assemblies of Iowa. He was very active in county politics in the Democratic Party. He was also a Director of the Iowa Savings Bank at Coon Rapids for many years. He made his home on his farm north of Coon Rapids, although he was retired from active farming.

He died December 25, 1963, at St. Anthony's Hospital in Carroll, Iowa.

In addition to his widow, Julia, Mr. Chrystal is survived by two sons, John Chrystal of Coon Rapids, Iowa; Tom Chrystal of Scranton, Iowa; and one daughter, Mrs. W. R. Davis, Salt Lake City, Utah. He was preceded in death by his first wife, Dorothy Garst, in 1936, and one daughter, Mary, in 1929.

JOHN S. GRAY

John S. Gray was born in Mahaska County on September 5, 1907, and passed away March 5, 1962, at the age of fifty-four. He was the son of Walter S. and Grace Wright Gray. On May 19, 1934, he married Helen Lamond of Oskaloosa. They had one son, John S. Gray of Oskaloosa.

Mr. Gray attended school and William Penn College in Oskaloosa, and Capital City Business College in Des Moines.

He entered active politics in 1954 when he was elected State Representative from Mahaska County. He served three terms, then was elected State Senator in 1960.

Mr. Gray served as Spring Creek Trustee and Assessor, was president of the Mahaska County Board of Education, Mahaska Farm Bureau, and Board of Trustees of the Central Methodist Church, and was a member of the Masonic Lodge, Rotary Club and the Oskaloosa Chamber of Commerce.

Mr. Gray had engaged in farming east of Oskaloosa.

In addition to his widow, Mr. Gray is survived by a son, John S. Gray of Oskaloosa, two brothers, Joe W. Gray of Oskaloosa and William W. Gray of Searsboro, and one sister, Mrs. L. Virgil Briggs of Hampton.

Therefore, Be It Resolved by the Senate of the Sixtieth General Assembly of Iowa: That in the passing of the Honorable John S. Gray, the state has lost an honored citizen and a faithful and useful servant, and the Senate by this resolution would express its appreciation of his service, and tender its sympathy to the members of his family.

HARRY S. LOVE

MR. PRESIDENT: Your committee, appointed to prepare a suitable resolution commemorating the life, character and public service of the late Harry S. Love, begs leave to submit the following:

Harry S. Love was born August 9, 1888. He lived on a farm until twenty-one years of age at which time he moved to Bridgewater, Iowa, where he engaged in the produce business. He was educated in the rural and Bridgewater schools.

On August 23, 1913, he married Miss Ethel McDermott.

He was a member of the Masons, served on the city school board for twenty years, several years on the city council and as a township trustee. He served three terms in the House of Representatives and was elected to two terms in the Senate. In 1944 he resigned from the Senate to accept an appointment from Governor Robert D. Blue to the State Board of Social Welfare. He served six years on the board as member, vice-chairman, then chairman.

Mr. Love died Sunday, July 23, 1961. In addition to his widow, Mr. Love is survived by Hildreth Firch of California, Beverly Moser of California, Jean Dewey of Florida, Larry J. Love of Wisconsin, nine grandchildren, one sister and one brother.
