EUGENE E. HALLING

Mr. Speaker: Your committee, appointed to prepare a suitable resolution commemorating the life, character, and public service of the late Honorable Eugene E. Halling, begs leave to submit the following memorial:

Eugene E. Halling was born May 20, 1895 in Orient, Iowa. On December 28, 1920, he was united in marriage to Margaret E. Shafar.

Mr. Halling was a graduate of Grinnell College and served in the United States Army during World War I. He served several years on the Hill of Zion Consolidated School Board. He was a deacon emeritus of the Hill of Zion Church and a charter member of the Orient American Legion and Greenfield Barracks 1533 of World War I. He farmed his family's farm in Adair County for about fifty-five years before retiring and moving into Creston in 1975.

A Republican, Mr. Halling represented Adair County in the Fifty-sixth, Fifty-seventh, Fifty-eighth, Fifty-ninth and Sixtieth General Assemblies. For twenty years he was a precinct committeeman for the Republican Party.

Eugene E. Halling died on February 18, 1982, at Creston, Iowa, at the age of 86. Survivors include his wife, Margaret, of Creston and a sister, Fern Johnston, of Huntington Beach, California. He was preceded in death by two sisters, Annabelle and Faye, and his parents, Mathias E. and Amanda Halling.

HAROLD L. KNIGHT

Mr. Speaker: Your committee, appointed to prepare a suitable resolution commemorating the life, character, and public service of the late Honorable Harold L. Knight, begs leave to submit the following memorial:

Mr. Knight was born February 10, 1911, the son of Charles D. and Mary Craven Knight, in Ames, Iowa. He was united in marriage on April 7, 1932 to Fern Bennett, to which union were born three sons.

After graduation from Iowa State University in 1937 as a Dairy Bacteriologist, he moved to Des Moines where he worked for Anderson-Erickson as a cottage cheese maker. In 1947 he moved to Humboldt, Iowa, where he established his own cottage cheese business called Knight's Cottage Cheese.

He was a member of the Methodist Church; past president of the Humboldt Chamber of Commerce; a former director of the First National Bank of Humboldt; and an active Mason, having been a member of the Red Cross of Constantine, the Knight Commander Court of Honor, the Honorary Legion of Honor, the Royal Order of Scotland, and the Order of Eastern Star and White Shrine. He was listed in Who's Who in Commerce and Industry, as well as Who's Who in the Midwest.

A Republican, Mr. Knight represented Humboldt and Pocahontas Counties in the Sixty-second and Sixty-third General Assemblies of the State of Iowa.

Mr. Knight moved to Horseshoe Bend, Arkansas, in 1974 and died July 19, 1982 in Calico Rock, Arkansas. He is survived by his widow, Fern, of Humboldt, Iowa; sons Ray L. of Humboldt, Iowa, Dean L. of Washington, Iowa, and Kent L. of West Columbia, South Carolina; brother, Don, of Richardson, Texas; sister, Mrs. Gladys Spearing, Manly, Iowa; and eight grandchildren.
