### HONORABLE JAMES N. HAYES

MR. SPEAKER: Your committee, appointed to prepare a suitable resolution commemorating the life, character, and public services of the Honorable James Nicholas Hayes, begs leave to submit the following memorial:

James Nicholas Hayes, the son of James A. and Philomena Cody Hayes, was born on February 9, 1897, at Dubuque, Iowa. He attended St. Mary's Parochial School, Dubuque, Iowa, and Champion Academy and College at Prairie de Chien, Wisconsin.

James Hayes performed honorable active service in the United States Navy from August 18, 1917, to April 14, 1919, on board the following ships and stations: Navy Training Camp, Charleston, S. Car., Naval Training Station, Great Lakes, Ill.; Naval Operating Base Hospital, Hampton Roads, Va., U. S. S. Georgia. A greater part of the time was spent overseas.

On September 6, 1922, he was married to Florence Wickham McVay. To this union five children were born, James N., Marian E., John P., and Florence A. A stepson, Robert McVay, was also raised in his home.

Elected to the House of Representatives from Dubuque county in 1929, he served in the Forty-second Extra, Forty-third and Forty-fourth General Assemblies.

In 1933 he was appointed State Automobile Inspector and was a member of the first Iowa State Patrol under Mrs. Alex Miller, Secretary of State. The following year he was appointed Assistant Chief of the State Driver's License Examiners.

In 1937 he was appointed Field Representative for the Iowa State Safety Council in the eastern half of Iowa.

He was a member of the Hayes-Schleuter Insurance Agency.

Mr. Hayes was widely known in semi-professional baseball circles and was prominent in all branches of athletics at Champion College. In 1922 he played in the Mississippi Valley Baseball league under McGinnity.

He died October 27, 1940, and funeral services were held at St. Raphael's Cathedral and interment was made in Mt. Olivet Cemetery, Dubuque.

When Mr. Hayes passed away, Dubuque lost one of its finest citizens and his family suffered the irreparable loss of a loving husband and parent.

Hayes, the state has lost a valuable and honored citizen, and the House would tender, by this resolution, its sincere sympathy to the surviving members of his family in their sorrow; and,

### HONORABLE ROY HANEY

MR. SPEAKER: Your committee, appointed to prepare a resolution commemorating the life, character and public services of the late Honorable Roy Haney of Mills county, Iowa, begs leave to submit the following:

Representative Roy Haney was born near Silver City, Mills county, Iowa, on July 28, 1878. He grew to manhood at the farm home near Glenwood, Iowa, where he was graduated from high school, followed by a course in Business Administration.

On January 16, 1907, he was united in marriage to Pearle Mintle in Glenwood, Iowa, where he has lived continuously since. In early life he became interested in farming and real estate and at the time of his passing he had built for himself an enviable record as a business man whose advice and business judgment were sought by many.

He gave generously of his time to civic affairs, serving several terms as Mayor of the City of Glenwood. He served as the President of the Chamber of Commerce of his city, and also served many years as treasurer of the Glenwood public schools. He was a member of the Methodist church and served in many official capacities with the church and gave freely of his time, energy and substance. He was a member of the Masonic Order, also of the Order of Eastern Star, having filled the highest offices of these orders. He was a member of the Mills County Building and Loan Association and was its president at the time of his death.

In politics he was a Republican and served his community and state well. His greatest political honor came, however, when he was elected as State Representative for Mills county and served in the Forty-first, Forty-second and Forty-second Extraordinary sessions. His record in the legislature shows that he was always for the common man, of which he was one.

Roy Haney died suddenly on February 10, 1941. He is survived by his wife. The glory of his life was his living; the test of his worth was his serving; his life and his service were his success—there is no greater, there is no other. His life and his service may be silent in the grave, but his influence will go on until time itself shall end.
