HONORABLE JOHN T. HAZEN

MR. SPEAKER: Your committee, appointed to prepare resolutions in commemoration of the life and services of the Hon. John T. Hazen, late of Pottawattamie county, beg leave to submit the following report:

Mr. Hazen was born in Dearborne county, Indiana, July 27, 1846, and died at Avoca, Iowa, June 29, 1931, at the age of 84 years. He was married to Miss Addie Jones in 1867, who died in 1869. He came to Pottawattamie county in 1871 where he was married a second time to Mrs. Julia Harris. Two daughters and two sons survive. He was the only democrat elected to office from his county in 1890, when he was elected sheriff and served two terms. While he was sheriff in April, 1894, he escorted Kelly's Army through the county, on their march across the continent. He served as a Representative in the Thirty-fourth and Thirty-fifth General Assemblies. He served as mayor, councilman and member of the school board and at his death was a director of the Citizens Savings Bank. He was a member of the I. O. O. F. Lodge and an active member of the Congregational church.

Therefore, Be It Resolved by the House of Representatives of the Forty-fifth General Assembly, That in the passing of the Hon. John T. Hazen the state has lost an honored and valuable citizen, a man of high ideals in Christian living and useful citizenship.

HONORABLE E. O. HELGASON

MR. SPEAKER: Your committee, appointed to prepare resolutions commemorating the life and services of the late Honorable E. O. Helgason of Armstrong, Iowa, beg leave to submit the following report:

Honorable E. O. Helgason was born in Mason City, Iowa, on November 7, 1872, and died of a heart attack at his home in Armstrong, Iowa, March 21, 1932. At the age of seven, he, with his parents moved on a farm in Seneca township, Kossuth county, and thereafter has always lived in Iowa except for three years he spent in Louisiana. He attended the

district school and completed a course in a business college and later attended the Iowa State College at Ames for two years, afterward teaching school for two years.

In 1900 he was united in matrimony to Mary Jenson and to this union were born five children, two sons, Lloyd and Lorenzo, who reside on farms near Armstrong and three daughters, Ione, Viola and Marietta, all of Armstrong.

Mr. Helgason was interested in public affairs for many years, having served as road superintendent, township trustee and clerk, Director of Armstrong Consolidated School eleven years, and president of it for eight years.

He served as republican committeeman and was elected to fill the vacancy in the House of Representatives from Emmet county upon the death of Representative R. B. Crone in the Forty-second extra session. In 1928 he was re-elected to the Forty-third and in 1930 he was again re-elected to the Forty-fourth General Assembly.

Therefore, Be It Resolved by the House of Representatives of the Forty-fifth General Assembly, That in the death of E. O. Helgason the state has lost a public spirited citizen and a man of high ideals. That the House of Representatives take this occasion to express its appreciation of his life and work and extend to his family sincere sympathy in their bereavement.

HONORABLE JOHN H. JENKS

MR. SPEAKER: Your committee appointed to prepare Resolutions in commemoration of the life and services of the Hon. John H. Jenks, late of Pottawattamie county, beg leave to submit the following report: Mr. Jenks was born in Belchertown, Massachusetts, September 25, 1855, and died at the Jennie Edmundson Hospital in Council Bluffs, May 31, 1931, at the age of 75 years. He attended the public schools at Earlville, Illinois, and the University of Chicago for two years. He was a large stock raiser and shipper. His word was as good as his bond. In all his dealings he was honest and upright. In 1892 he became cashier of the Avoca State Bank and in 1900 was elected its president, in which capacity he served until his death. He served as a Representative in the Twenty-eighth and Twenty-ninth General Assemblies. He was married to Ann Heslet of Mendota, Illinois, in 1881 and at his death lacked but sixteen days of celebrating his fiftieth wedding anniversary. To them was born a son, who died at birth, and a daughter, Mrs. William Knutson, of Hinsdale, Illinois, who survives him.
