Claude Johnson was born December 19, 1878, on a farm near Rippey, Iowa, and passed away June 30, 1957, at the age of 79 years.

He graduated from the Washington Township High School and taught several terms in the local schools.

He was united in marriage on November 16, 1902 to Nora Morain.

Mr. Johnson was one of the organizers of the consolidated school and served on the board of education during the consolidation and building program and continued to serve for a number of years. He was chairman of the first farm program in Greene County. He served many years as president of the Rippey Mutual Telephone Company.

Mr. Johnson was elected to the state legislature as Representative from Greene County and served during the Forty-seventh General Assembly in 1937.

He was a member of the Elmo Lodge No. 465 of the Masons of Rippey.

His interest in public affairs on a community, state, or national level was very keen up until his death.

## JAMES F. JOHNSTON

James F. Johnston was born in Lucas county, April 25, 1875, and passed away at Chariton, Iowa, on November 6, 1958.

He was the son of John and Rebecca Johnston.

He was educated in rural schools, Western Normal school and Simpson College. He taught school and later engaged in general farming and stock raising.

Mr. Johnston was a lifelong member of the Methodist Church, and a member of the Lucas county board of supervisors for three years.



He was intensely interested in governmental, legislative and political affairs and was first elected as a state representative in 1914, serving in the Thirty-sixth, Thirty-seventh and Forty-sixth sessions of the General Assembly, and as a State Senator from the Lucas-Wayne district in the Thirty-ninth, Fortieth and Fortieth Extra sessions.

Surviving Mr. Johnston is a brother, Charles M. Johnston of Zanesville, Ohio, and four sisters, Lida R. Shore, Florence V. Prior, Bernice Johnston, and Nora Johnston of Chariton; three nephews and five nieces. One sister, Mrs. Belle Brown, and a brother, Matthew Johnston, preceded him in death.

Ralph C. Keho, farmer, livestock feeder, and legislator, was born on a afrm west of Allerton, Iowa, in Wayne county, on January 13, 1896, and passed away on July 8, 1958.

The son of James and Ella Keho, he grew up in the cattle and livestock feeding business with his father, and spent all his life on a Wayne county farm, with the exception of two years which were spent in Phoenix, Arizona.

He was united in marriage with Elma Williams in 1929, into which union two sons were born.
