HAROLD L. KNIGHT

Mr. Speaker: Your committee, appointed to prepare a suitable resolution commemorating the life, character, and public service of the late Honorable Harold L. Knight, begs leave to submit the following memorial:

Mr. Knight was born February 10, 1911, the son of Charles D. and Mary Craven Knight, in Ames, Iowa. He was united in marriage on April 7, 1932 to Fern Bennett, to which union were born three sons.

After graduation from Iowa State University in 1937 as a Dairy Bacteriologist, he moved to Des Moines where he worked for Anderson-Erickson as a cottage cheese maker. In 1947 he moved to Humboldt, Iowa, where he established his own cottage cheese business called Knight's Cottage Cheese.

He was a member of the Methodist Church; past president of the Humboldt Chamber of Commerce; a former director of the First National Bank of Humboldt; and an active Mason, having been a member of the Red Cross of Constantine, the Knight Commander Court of Honor, the Honorary Legion of Honor, the Royal Order of Scotland, and the Order of Eastern Star and White Shrine. He was listed in Who's Who in Commerce and Industry, as well as Who's Who in the Midwest.

A Republican, Mr. Knight represented Humboldt and Pocahontas Counties in the Sixty-second and Sixty-third General Assemblies of the State of Iowa.

Mr. Knight moved to Horseshoe Bend, Arkansas, in 1974 and died July 19, 1982 in Calico Rock, Arkansas. He is survived by his widow, Fern, of Humboldt, Iowa; sons Ray L. of Humboldt, Iowa, Dean L. of Washington, Iowa, and Kent L. of West Columbia, South Carolina; brother, Don, of Richardson, Texas; sister, Mrs. Gladys Spearing, Manly, Iowa; and eight grandchildren.

Mr. Miller was born November 28, 1914 in Clarinda, Iowa. On February 14, 1935 he was united in marriage to Beulah Mary Otte, to which union two daughters were born.

As a student he was active in 4-H and FFA, and began farming directly out of high school in Page County, While farming, he helped form the Page County Angus Association, for which he served as secretary for many years. In 1946 the family moved to Shenandoah where he opened a farm equipment dealership. During his years as a businessman in Shenandoah he was active in many civic organizations, including: Junior Chamber of Commerce, President; Senior Chamber of Commerce, President; Shenandoah Industries, Executive Secretary; Shenandoah City Council; Yorktown School Board; Rotary International, Board of Directors; Izaak Walton, Board of Directors; Masonic Lodge No. 300; B.P.O. Elks; Order of Eastern Star No. 81; Honorary member of FFA in the Davis-Rodgers chapter in Shenandoah; and Mid-West Implement Dealers Association, Board of Directors. The National Brand Names Award for Implement Dealers was presented to Mr. Miller in 1960.
