Ernst Lieberknecht was born on a farm in Louisa County near Letts, Iowa, on September 25, 1883, the son of Henry Lieberknecht and Salome Wiederrecht. He attended the rural school and graduated from the Letts High School in 1900, and afterward became a student at Iowa State College for two and one-half years, where he specialized in animal husbandry.

A. L. Mensing was born near Lowden, Iowa on October 27, 1896, son of Diedrich and Louise Ernsting Mensing.

Mr. Mensing married Elsa Rodenbeck in 1919 and to this union two sons were born.

Mr. Mensing operated a general mercantile business from 1915 until retirement January 1, 1953. He was vice president and director of American Trust and Savings Bank of Lowden.
