HONORABLE FRANK S. LOVRIEN

MR. SPEAKER: Your committee appointed to prepare resolutions commemorating the life, character, and public service of the Honorable Frank S. Lovrien, Humboldt, Humboldt county, Iowa, beg leave to submit the following report:

Frank S. Lovrien was born August 27, 1882, near Bradgate, Iowa. His death occurred at the Clarkson Memorial Hospital in Omaha, Nebraska, July 9, 1939.

As a boy he attended the Humboldt county schools, then Humboldt College, Des Moines College, and Drake University Law School. He was prominent in high school athletics, particularly football, and was captain of Drake's football team in 1905, a team of considerable prominence at that time.

Mr. Lovrien began the practice of law in Humboldt, Iowa, in February of 1908. That May he was married to Miss Caroline Connor of Humboldt. Three children were born to this marriage: Clark Edward Lovrien, Britt, Iowa, now county attorney of Hancock; Philip Connor Lovrien, Humboldt, county attorney of Humboldt; and Harriet Ann Lovrien, Des Moines, Iowa. Mrs. Lovrien died in 1930.

Mr. Lovrien was a member of the Congregational church. He served many years as City Attorney of Humboldt; was active in local banking; a member of the Masons, Eastern Star, Shrine, and the Elks. He also served on the Humboldt School Board.

In 1932 he married Mrs. Harriet Byers Randall of Des Moines, Iowa. They had one child, Jeanne Carolyn Lovrien, and one step-daughter, Virginia Randall.

Mr. Lovrien is survived by Mrs. Lovrien, five children; and brothers, Ned R. Lovrien of Omaha; A. K. Lovrien of Detroit; Orvis Lovrien of Humboldt; and Judge Fred Lovrien of Spencer; two sisters, Miss Genorie Lovrien of Chicago, and Mrs. E. H. Bennett of Ames, Iowa.

Mr. Lovrien was one of Humboldt county's most substantial citizens and always took a prominent part in civic affairs. He was elected and served in the House of Representatives in the Forty-seventh General Assembly of the State of Iowa, and during his service there was one of the active, progressive members. He was a Republican in politics but a man who placed principle above all else. His word was as good as his bond, and he took pride in meeting his obligations promptly and was always willing to share his part of the burden in the performance of any public duty. He served not only his community but the state of Iowa with credit and distinction.

Therefore, Be It Resolved, That in the passing of the Honorable Frank S. Lovrien of Humboldt county, Iowa, the state of Iowa has lost a valuable and honored citizen, a conscientious statesman, and the family a loving husband and father.

HONORABLE C. ORVILLE LEE

MR. SPEAKER: Your committee, appointed to prepare suitable resolutions commemorating the life, character, and public services of the late Honorable C. Orville Lee, begs leave to submit the following memorial:

C. Orville Lee was born in Sac City, Iowa, November 18, 1860. He received his education in common schools of the community and later attended Cornell College at Mt. Vernon, Iowa. After graduating he taught school for several years.

When he attained the age of twenty-one his parents gave him 160 acres of prairie land which was the beginning of his ownership of some of the best improved land and farms in this section of the country.

In the year 1884 he was united in marriage to Cecelia Eugene Rogers. To this union were born two sons, LaVern and Ward, both of Sac City.

In 1892, moving his family to Sac City, Mr. Lee purchased a grain elevator which he operated for nine years. Later he engaged in the real estate business and for many years was a successful auctioneer. He also was a licensed public surveyor.

On March 16, 1934, he and his family celebrated their fiftieth wedding anniversary. Mr. Lee was one of Sac county's leading citizens for more than half a century, always interested in community affairs, serving as city mayor, member of the school board, library board, and for many years a trustee of Sac City Institute.

He was a member of the Baptist church since 1894 and filled various church offices. He was a member of the local Blue Lodge, Chapter and Commandery, and Order of the Mystic Shrine, Abu Bekr Temple.

Allied with the Republican party, he served two terms in the State Legislature as Representative of Sac county, a member of the Thirty-sixth and Thirty-seventh General Assemblies, convening in 1915 and 1917.

He was preceded in death by Mrs. Lee who passed away November 5, 1936.

Two years ago Mr. Lee suffered a paralytic stroke to which he made sufficient recovery. Last October a second stroke indicated the inevitable and he passed away Monday evening, January 20, 1941, at his home on South 12th Street, Sac City, Iowa.
