R. G. (Hap) Miller was born in Dahlgren, Illinois, on September 17, 1907, the son of Charlie and Nellie Gray Miller.

He attended high school at Zearing, Iowa and graduated with a B.S. degree from Iowa State Teachers College in 1936. He did graduate work at the University of Denver and the University of Nevada.

Mr. Miller married Opal Dellinger in 1935. They had six chldren: Mrs. Joe Hall of Des Moines, Mrs. James Rundle of Indianola, Mrs. Robert Bigham of Bryan, Texas; Mrs. Jay Eaton of Shaker Heights, Ohio; John of Oklahoma City, Oklahoma, and Sue Miller at home.

Mr. Miller had been athletic director, coach and government instructor sixteen years in high schools and fifteen years on the college level.
