Allert G. Olson was born in Rudd Township, Floyd County, Iowa, March 13, 1896, the son of Martha M. and Martin B. Olson. He attended rural schools, Cedar Valley Seminary, Osage High School and, following graduation, attended Iowa State College. He left college to enlist for World War I, serving overseas with the 88th Division.

Mr. Olson married Rikka M. H. Haugen in 1927. To this union were born four children: Yvonne, Aida, Joyce and A. Gilman, Jr.

He was a pioneer of rural electric co-operatives in the Midwest, serving as president of the Co-op Electric Co.; secretary of Dairyland Power Co-operative; vice president of Iowa Rural Electric Co-op; and director of the National Rural Electric Co-operative Association. He also served as a director of the Home and Trust Savings Bank of Osage.

Mr. Olson was an active member of the Osage Evangelical Lutheran Church, the American Legion, Commandery, Consistory and Shrine.

Mr. Olson, a Republican, was a member of the Fifty-first, Fifty-second, Fifty-third and Fifty-fourth General Assemblies, representing Mitchell County. He passed away on April 11, 1976.

Roy J. Smith was born September 28, 1889, in Whiteside County, Illinois, and attended school in Hardin County, Iowa. He later was a teacher in the Hardin County School District.

He moved to Dickinson County in 1913, and was owner and operator of the Jersey Dell Farm. He was a member of the National Dairy Association and was past president of the Iowa Dairy Commission. Mr. Smith passed away on July 27, 1975, at the Dickinson County Memorial Hospital. Services were held at the United Methodist Church with burial at the Lake View Cemetery.
