This summary highlights differences between SF 609 and the House Appropriations Committee amendment.

Senate File 609 transfers \$200,000 from the DALs General Fund to the ISU Veterinary Diagnostic Laboratory contingent upon passage of SF 601 (Pesticide Applicator Fee Bill). <p>Other Funds Difference Compared to SF 609: The amendment appropriates \$100,000 less than SF 609 from Other Funds for FY 2020.
