**FUNDING SUMMARY**

---

**Other Funds — FY 2022:** This Bill appropriates a net total of \$108.6 million for FY 2022 from the following sources:

- Rebuild Iowa Infrastructure Fund (RIIF): \$92.4 million in FY 2022.
- Technology Reinvestment Fund (TRF): \$14.7 million in FY 2022.
- Sports Wagering Receipts Fund (SWRF): \$1.5 million in FY 2022.

**Autism Support Fund Transfer:** This Bill transfers \$750,000 from the Autism Support Fund to the RIIF in FY 2022.

**Rebuild Iowa Infrastructure Fund — Other Years:** This Bill also appropriates \$17.1 million in FY 2023 and \$1.9 million in FY 2024.

**General Fund — FY 2022:** This Bill increases the standing appropriation from the General Fund to the TRF for FY 2022 from \$17.5 million to \$17.7 million. This action funds the TRF for FY 2022 and makes funding available for \$14.7 million in new TRF appropriations in this Bill and \$3.0 million in FY 2022 appropriations that were previously enacted. To avoid double counting, this \$17.7 million appropriation is excluded from the totals above.

 1 2 REBUILD IOWA INFRASTRUCTURE FUND  
 1 3 Section 1. REBUILD IOWA INFRASTRUCTURE FUND —  
 1 4 APPROPRIATIONS. There is appropriated from the rebuild Iowa  
 1 5 infrastructure fund to the following departments and agencies  
 1 6 for the following fiscal years, the following amounts, or so  
 1 7 much thereof as is necessary, to be used for the purposes  
 1 8 designated:

1 9 1. DEPARTMENT OF ADMINISTRATIVE SERVICES  
 1 10 For security cameras on the state capitol complex,  
 1 11 notwithstanding section 8.57, subsection 5, paragraph “c”:  
 1 12 FY 2021-2022:  
 1 13 ..... \$ 250,000

Rebuild Iowa Infrastructure Fund (RIIF) appropriation to the Department of Administrative Services (DAS) to upgrade security cameras on the Capitol Complex. This appropriation is exempt from the vertical infrastructure requirement in Iowa Code section [8.57](#)(5)(c).

DETAIL: The project is intended to replace security cameras, video recorders, and install new fiber to support the system.

1 14 2. DEPARTMENT OF AGRICULTURE AND LAND STEWARDSHIP

1 15 a. For deposit in the water quality initiative fund created  
 1 16 in section 466B.45 for purposes of supporting the water quality  
 1 17 initiative administered by the division of soil conservation  
 1 18 and water quality as provided in section 466B.42, including  
 1 19 salaries, support, maintenance, and miscellaneous purposes,  
 1 20 notwithstanding section 8.57, subsection 5, paragraph “c”:  
 1 21 FY 2021-2022:  
 1 22 ..... \$ 5,200,000

Rebuild Iowa Infrastructure Fund appropriation to the Iowa Department of Agriculture and Land Stewardship (DALS) for the Iowa Water Quality Initiative. This appropriation is exempt from the vertical infrastructure requirement in Iowa Code section [8.57](#)(5)(c).

DETAIL: The Iowa Water Quality Initiative provides funding for prioritized watersheds to implement conservation practices that will reduce nutrient transport to bodies of water in Iowa. Funded projects are typically managed by soil and water conservation districts. The Initiative was appropriated \$5,200,000 from the RIIF each year from FY 2017 through FY 2021. The Initiative has also received funding from the General Fund. Since FY 2013, the Water Quality Initiative has received a total of \$78,220,201 from the General Fund, Environment First Fund, and RIIF.

1 23 b. (1) The moneys appropriated in this subsection shall  
 1 24 be used to support demonstration projects in subwatersheds as  
 1 25 designated by the department that are part of high-priority  
 1 26 watersheds identified by the water resources coordinating  
 1 27 council.

Requires the funds to be used to support demonstration projects in subwatersheds that are included within high-priority watersheds as identified by the Water Resources Coordinating Council.

1 28 (2) The moneys appropriated in this subsection shall be

1 29 used to support demonstration projects in watersheds generally,  
 1 30 including regional watersheds, as designated by the division  
 1 31 and high-priority watersheds identified by the water resources  
 1 32 coordinating council.

1 33 c. In supporting projects in watersheds and subwatersheds  
 1 34 as provided in paragraph "b", all of the following shall apply:

1 35 (1) The demonstration projects shall utilize water quality  
 2 1 practices as described in the latest revision of the document  
 2 2 entitled "Iowa Nutrient Reduction Strategy" initially presented  
 2 3 in November 2012 by the department of agriculture and land  
 2 4 stewardship, the department of natural resources, and Iowa  
 2 5 state university of science and technology.

2 6 (2) The division shall implement demonstration projects as  
 2 7 provided in subparagraph (1) by providing for participation by  
 2 8 persons who hold a legal interest in agricultural land used in  
 2 9 farming. To every extent practical, the division shall provide  
 2 10 for collaborative participation by such persons who hold a  
 2 11 legal interest in agricultural land located within the same  
 2 12 subwatershed.

2 13 (3) The division shall implement demonstration projects on  
 2 14 a cost-share basis as determined by the division. Except for  
 2 15 edge-of-field practices, the state's share of the amount shall  
 2 16 not exceed 50 percent of the estimated cost of establishing the  
 2 17 practice as determined by the division or 50 percent of the  
 2 18 actual cost of establishing the practice, whichever is less.

2 19 (4) The demonstration projects shall be used to educate  
 2 20 other persons about the feasibility and value of establishing  
 2 21 similar water quality practices. The division shall promote  
 2 22 field day events for purposes of allowing interested persons to  
 2 23 establish water quality practices on their agricultural land.

2 24 (5) The division shall conduct water quality evaluations  
 2 25 within supported subwatersheds. Within a reasonable period  
 2 26 after accumulating information from such evaluations, the  
 2 27 division shall create an aggregated database of water quality  
 2 28 practices. Any information identifying a person holding a  
 2 29 legal interest in agricultural land or specific agricultural  
 2 30 land shall be a confidential record.

2 31 d. The moneys appropriated in this subsection shall be used  
 2 32 to support education and outreach in a manner that encourages  
 2 33 persons who hold a legal interest in agricultural land used for

Specifies the following criteria for projects in high-priority watersheds:

- Requires that projects utilize water quality practices described in the latest version of the Iowa Nutrient Reduction Strategy.
- Requires the DALs to collaborate with agricultural landowners in targeted watersheds.
- Prohibits the State's cost-share amount for water quality protection practices from exceeding 50.00% of the value of the practices, except in instances of edge-of-field practices.
- Requires that demonstration projects be used to educate the public about water quality practices.
- Requires the DALs to conduct water quality evaluations within targeted watersheds and create a database of water quality practices. All information received is a confidential record and exempt from public access.

Requires the DALs to support education and outreach to encourage agricultural producers to establish water quality practices.

2 34 farming to implement water quality practices, including the  
 2 35 establishment of such practices in watersheds generally, and  
 3 1 not limited to subwatersheds or high-priority watersheds.

3 2 e. The moneys appropriated in this subsection may be used  
 3 3 to contract with persons to coordinate the implementation of  
 3 4 efforts provided in this subsection.

Permits the DALs to use funds for contracts that will assist with the coordination and implementation of the Iowa Water Quality Initiative.

3 5 f. The moneys appropriated in this subsection may be used  
 3 6 by the department to support urban soil and water conservation  
 3 7 efforts, which may include but are not limited to management  
 3 8 practices related to bioretention, landscaping, the use of  
 3 9 permeable or pervious pavement, and soil quality restoration.  
 3 10 The moneys shall be allocated on a cost-share basis as provided  
 3 11 in chapter 161A.

Permits the DALs to use funds to support urban soil and water conservation practices and to allocate funds on a cost-share basis.

3 12 g. Notwithstanding any other provision of law to the  
 3 13 contrary, the department may use moneys appropriated in this  
 3 14 subsection to carry out the provisions of this subsection on a  
 3 15 cost-share basis in combination with other moneys available to  
 3 16 the department from a state or federal source.

Permits the DALs to use the appropriated funds to implement projects on a cost-share basis and in combination with other funds available to the Department.

Permits up to 10.00% of the appropriated funds for the Water Quality Initiative to be used for administration and implementation of the Initiative by the Soil Conservation Division.

DETAIL: The funds for administration and implementation of the Water Quality Initiative from the RIIF will total \$520,000 in FY 2022.

Rebuild Iowa Infrastructure Fund appropriation to the Department for the Blind for building repairs.

DETAIL: This appropriation will fund the replacement of a boiler at the Department for the Blind. The Department last received an appropriation from the RIIF in FY 2018. The previous appropriation was \$150,000 and was used for elevator improvements.

3 26 4. DEPARTMENT OF CORRECTIONS  
 3 27 For the remodel and expansion of the kitchen and visitation  
 3 28 areas at the Clarinda treatment complex:  
 3 29 FY 2021-2022:  
 3 30 ..... \$ 5,242,619

Rebuild Iowa Infrastructure Fund appropriations for FY 2022 and FY 2023 to the Department of Corrections to remodel and expand the kitchen and visitation areas at the Clarinda Correctional Facility.

DETAIL: These appropriations will fund the expansion of the kitchen

for the Clarinda Correctional Facility. The existing kitchen is outside the perimeter of the prison and is need of updates. The Department believes this remodel will increase food safety and decrease opportunities for contraband to be smuggled into the prison.

Rebuild Iowa Infrastructure Fund appropriation to the Department of Cultural Affairs (DCA) for the Iowa Great Places Infrastructure Grant Program.

DETAIL: Funding for the Iowa Great Places Initiative is intended to enhance the cultural development of Iowa communities. The Iowa Great Places Program Fund was created during the 2006 Legislative Session and was first funded in FY 2007. In addition to this appropriation, the Program has been appropriated a total of \$21,900,000 since FY 2007. The funding has included:

- FY 2012 - FY 2021: \$1,000,000 per year from the RIIF
- FY 2011: \$2,000,000 from the Revenue Bond Capitals Fund (RBC)
- FY 2010: \$1,900,000 from the RIIF
- FY 2009: \$2,000,000 from the RIIF
- FY 2008: \$3,000,000 from the RIIF
- FY 2007: \$3,000,000 from the Restricted Capitals Fund (RCF)

4 5 b. For grants to nonprofit organizations committed to  
 4 6 strengthening communities through youth development, healthy  
 4 7 living, and social responsibility for costs associated with  
 4 8 the renovation and maintenance of facility infrastructure at

Rebuild Iowa Infrastructure Fund appropriation to the DCA for grants to nonprofit organizations committed to youth development, healthy living, and social responsibility in cities with a population of less than 28,000.

DETAIL: The funds will be used primarily to provide grants to communities for building and facility improvements to YMCA facilities located in cities with a population of less than 28,000. In total, \$2,000,000 has been appropriated since FY 2016 for these projects. Project examples include updated boiler systems, roofs, parking access, energy efficiency improvements, and renovations to gyms and classrooms.

Rebuild Iowa Infrastructure Fund appropriation to the Iowa Economic Development Authority (IEDA) for the Community Attraction and Tourism (CAT) Program.

DETAIL: Since FY 2015, the CAT Program has received a \$5,000,000 annual appropriation for a total of \$35,000,000.

Eligible applicants include cities, counties, public organizations, and school districts in cooperation with a city or county. Previously funded projects include the development of attractions such as wellness centers, recreational centers, parks, recreational trails, swimming pools and aquatic centers, riverfront plazas and marinas, streetscapes, museums, libraries, performing arts centers, sports complexes, public gardens, visitor centers, and campgrounds.

4 25 b. For deposit in the vacant state buildings demolition fund
