FEDERAL BLOCK GRANT APPROPRIATIONS BILL - AS AMENDED

FUNDING SUMMARY

House File 709 authorizes the receipt and expenditures of federal block grant funds totaling \$424.0 million for FFY 2024 and \$427.8 million for FFY 2025. The Bill authorizes federal block grant funds on a federal fiscal year basis. The federal funding levels specified in this Bill are based on projected spending authority yet to be authorized by Congress.

Page 1, Line 2

Division II authorizes prior year receipt and expenditure of Community Development Block Grant (CDBG) funds totaling \$57.6 million for FFY2021.

NEW PROGRAMS, SERVICES, OR ACTIVITIES

Changes allocations for specified programs from the Division of Community Action Agencies, a former division of the Department of Human Rights, to the Department of Health and Human Services (HHS).
