MAJOR INCREASES/DECREASES/TRANSFERS OF EXISTING PROGRAMS

Suspends the General Fund standing appropriation of \$14.8 million to the Department of Education for the Instructional Support Program for FY 2024. Page 1, Line 4

Reduces the FY 2024 State school aid funding to Area Education Agencies (AEAs) by \$22.1 million. Page 2, Line 22

SIGNIFICANT CODE CHANGES

Transfers excess Economic Emergency Fund moneys to the General Fund. The amount transferred will be the difference between the total statewide foundation property tax initially calculated for FY 2024 and the total statewide foundation property tax in FY 2024 after the passage of [Senate File 181](#) (Residential Assessment Limitations Act). The Department of Management will determine the amount to be transferred. Page 1, Line 23

Requires a total equal to the difference between the actual net revenue for the General Fund for the fiscal year and the adjusted revenue estimate less the amount transferred to the General Fund for SF 181, as determined by the DOM, to be transferred to the Taxpayer Relief Fund. All remaining funds will be transferred to the General Fund.

Adopts corrective provisions related to [SE 514](#) (State Government Alignment Act). Page 3, Line 24

Adopts corrections to various Acts enacted during the 2023 Legislative Session. Page 10, Line 17

EFFECTIVE DATE

Specifies that Section 3 of the Bill, which distributes moneys from the Economic Emergency Fund for FY 2023, takes effect upon enactment. Page 3, Line 16

Specifies that Sections 15 and 27 of the Bill, which pertain to the duties of the Director of the Department of Inspections, Appeals, and Licensing, takes effect upon enactment and applies retroactively to March 22, 2023. Page 10, Line 5

Specifies that various sections of the Bill take effect upon enactment. Page 13, Line 18

CODE: Reduces the FY 2024 State school aid funding to Area Education Agencies (AEAs) by \$22,057,131.

DETAIL: In addition to the \$22,057,131 State aid reduction for FY 2024, the AEAs have an annual statutory reduction of \$7,500,000. The State aid reduction to the AEAs will total \$29,557,131 for FY 2024. Funding was reduced by \$24,557,131 in FY 2023.

Appropriates \$122,350,000 to the Department of Revenue for the Business and Property Tax Credit.

DETAIL: This is a standing limited appropriation. Funding appropriated in this Bill reflects a decrease of \$2,650,000 compared to estimated FY 2023.
