#### **FUNDING SUMMARY**

Provides an FY 2024 General Fund supplemental appropriation of \$75,000 to the Iowa Economic Development Authority (IEDA) for a grant to support the Commissioning Committee of the U.S.S. Iowa SSN 797. The IEDA may use up to 5.0% (\$3,750) of the moneys appropriated to administer the funds. Unencumbered or unobligated moneys appropriated by this Bill will remain available for expenditure through June 30, 2025.
