NEW PROGRAMS, SERVICES, OR ACTIVITIES

Creates a Court Reporter Equipment Incentive Program under the control of the Iowa Economic Development Authority (IEDA).

Page 1, Line 1

Provides that the Court Reporter Equipment Incentive Program is comprised of two programs, the Student Grant Program and the Graduate Forgivable Loan Program. Grant recipients must meet the following criteria:

- A person is eligible to apply for a grant from the Student Grant Program to purchase court reporter equipment and software if the person is enrolled in a court reporter course at a school in Iowa and demonstrates financial need.
- A person is eligible to apply for a loan under the Graduate Forgivable Loan Program to purchase court reporter equipment and software if the person is newly licensed within one year of graduation from a court reporter program, is a resident of Iowa, and agrees to work as a court reporter for five years after the date of the loan.

Provides that applicants to the Court Reporter Equipment Incentive Program who are doing court-related work are to receive priority over applicants who are not. The Bill provides repayment requirements for the Graduate Forgivable Loan Program.

Establishes the Court Reporter Equipment Incentive Fund under IEDA. Within the Fund two accounts are created, the Student Grant Account and the Graduate Forgivable Loan Account.
