AGRICULTURE AND NATURAL RESOURCES APPROPRIATIONS BILL

FUNDING SUMMARY

General Fund FY 2025: Appropriates a total of \$47.0 million from the General Fund and 1,618.0 full-time equivalent (FTE) positions for FY 2025. This is an increase of \$3.5 million and an increase of 204.0 FTE positions compared to estimated FY 2024. The total includes an increase of \$500,000 that is contingent upon the administration of the Butchery Innovation Program being transferred from the Iowa Economic Development Authority (IEDA) to the Department of Agriculture and Land Stewardship (DALS).

The General Fund changes include:

- An increase of \$997,000 to Department of Natural Resources (DNR) Operations.
- An increase of \$982,000 to the DALS Administrative Division.
- A new appropriation of \$500,000 for the Butchery Innovation and Revitalization Program contingent upon the transfer of the administration of the Program to the DALS.
- A new appropriation of \$250,000 to support park accessibility in State Parks and recreation areas.
- A new appropriation of \$250,000 for a new Choose Iowa Food Purchasing Pilot Program.
- A new appropriation of \$150,000 to assist with moving expenses for the Iowa State University (ISU) Veterinary Diagnostic Laboratory.
- A new appropriation of \$150,000 for forestry management.
- An increase of \$100,000 for livestock disease research.
- An increase of \$100,000 to the Choose Iowa Promotional Program.

Other Funds FY 2025: Appropriates a total of \$96.4 million from other funds. This is no change compared to estimated FY 2024. This Bill appropriates \$49.8 million from the Fish and Wildlife Trust Fund, \$42.0 million from the Environment First Fund (EFF), \$3.5 million from the Groundwater Protection Fund (GWPF), and \$1.2 million from various other funds.

Iowa Code section <u>8.57A</u> contains a standing appropriation of \$42.0 million from the Rebuild Iowa Infrastructure Fund (RIIF) to the EFF, and this Bill appropriates the following amounts to the following departments for FY 2024:

- \$17.3 million to the DALS.
- \$24.0 million to the DNR.
- \$695,000 to the University of Iowa (UI).

This Bill appropriates \$12.0 million from the EFF to the Resource Enhancement and Protection (REAP) Fund in lieu of the \$20.0 million General Fund standing appropriation in Iowa Code chapter 455A and
