**NEW PROGRAMS, SERVICES, OR ACTIVITIES**

---

Requires the Iowa Economic Development Authority (IEDA) to establish and administer the Grocer Reinvestment Program to award financial assistance to eligible Iowa grocery stores for certain projects. Page 1, Line 13

Requires the IEDA to establish and administer the Local Produce Processing Grant Program to award grants to Iowa-based entities to increase the availability of local produce processing. Page 3, Line 7

**FUNDING FOR PROJECTS AND PROGRAMS**

---

Requires a grocery store to provide matching funds equal to the financial assistance received under the Grocer Reinvestment Program. Limits financial assistance to \$100,000 per project. Page 2, Line 7

Establishes the Grocer Reinvestment and Local Food Processing Fund under the IEDA. The Fund will be used to provide financial assistance under the Grocer Reinvestment Program and the Local Produce Processing Grant Program. Page 3, Line 23

Allocates \$100,000 of an annual appropriation to the Grocer Reinvestment and Local Food Processing Fund, or 10.0% of the moneys in the Fund available on July 1 of each year, whichever is less, to the Local Produce Processing Grant Program. Page 3, Line 34

**STUDIES AND INTENT**

*Nonreversion*

Allows unexpended funds in the Grocer Reinvestment and Local Food Processing Fund to remain available for expenditure through the following fiscal year. Interest or earnings on moneys in the Fund are credited to the Fund. Page 4, Line 9

*Required Reports*

Requires the IEDA Director to submit a report on the Grocer Reinvestment Program to the General Assembly by November 1, 2026, and each November 1 thereafter, if financial assistance was awarded in the preceding fiscal year. Page 2, Line 27

3 23 Sec. 3. NEW SECTION 15.415 GROCER REINVESTMENT AND LOCAL  
3 24 FOOD PROCESSING FUND.

3 25 1. a. A grocer reinvestment and local food processing  
3 26 fund is created in the state treasury under the control of the  
3 27 authority. The fund shall consist of moneys appropriated by  
3 28 the general assembly to the authority and any other moneys  
3 29 available to, obtained by, or accepted by the authority  
3 30 for placement in the fund. The fund shall be used to award  
3 31 financial assistance as provided under the grocer reinvestment  
3 32 program established in section 15.413 and the local produce  
3 33 processing grant program established in section 15.414.

3 34 b. Commencing with the fiscal year beginning July 1, 2025,  
3 35 and each fiscal year thereafter, one hundred thousand dollars  
4 1 of the annual appropriation to the fund, or ten percent of the  
4 2 moneys in the fund available on July 1, whichever is less,  
4 3 shall be allocated to the local produce processing grant  
4 4 program established in section 15.414.

CODE: Requires the IEDA to establish and administer the Local Produce Processing Grant Program to award grants to Iowa-based entities to increase the availability of local produce processing. Requires the IEDA to prioritize grants that will increase the availability, access, efficiency, or capacity of local produce processing.

CODE: Prohibits a grant from being awarded under the Local Produce Processing Grant Program unless the local produce processing includes produce from multiple Iowa-based farms.

CODE: Allows the IEDA to adopt administrative rules to administer the Local Produce Processing Grant Program.

CODE: Establishes the Grocer Reinvestment and Local Food Processing Fund under the IEDA. The Fund will be used to provide financial assistance under the Grocer Reinvestment Program and the Local Produce Processing Grant Program.

CODE: Allocates \$100,000 of an annual appropriation to the Grocer Reinvestment and Local Food Processing Fund, or 10.00% of the moneys in the Fund available on July 1 of each year, whichever is less, to the Local Produce Processing Grant Program.

4 5 c. The authority may use not more than five percent of  
 4 6 the moneys in the fund at the beginning of the fiscal year  
 4 7 for purposes of administrative costs, marketing, technical  
 4 8 assistance, and other program support.

CODE: Allows the IEDA to use up to 5.00% of the moneys in the Grocer Reinvestment and Local Food Processing Fund at the beginning of each fiscal year for administrative costs, marketing, technical assistance, and other program support.

4 9 2. Notwithstanding section 8.33, moneys in the fund  
 4 10 that remain unencumbered or unobligated at the close of the  
 4 11 fiscal year shall not revert but shall remain available for  
 4 12 expenditure for the purposes designated until the close of  
 4 13 the succeeding fiscal year. Notwithstanding section 12C.7,  
 4 14 interest or earnings on moneys in the fund shall be credited  
 4 15 to the fund.

4 20 1. The purpose of this chapter is to empower farmers, and  
 4 21 food entrepreneurs, and grocery stores to provide for strong  
 4 22 local food economies that promote self-sufficiency and job  
 4 23 growth in the agricultural sector and allied sectors of the  
 4 24 economy.

4 25 Sec. 5. Section 267A.1, subsection 2, paragraph d, Code  
 4 26 2025, is amended to read as follows:

CODE: Adds increasing jobs that retail local food to the list of goals of the Local Food and Farm Program.

4 27 d. Increase the number of jobs in this state's farm and  
 4 28 business economies associated with producing, processing,  
 4 29 distributing, retailing, and marketing local food.

4 30 Sec. 6. Section 267A.1, subsection 2, Code 2025, is amended  
 4 31 by adding the following new paragraph:

CODE: Adds increasing the availability and viability of grocery stores to the list of goals of the Local Food and Farm Program.

4 32 NEW PARAGRAPH e. Increase the availability and viability  
 4 33 of grocery stores in this state.

4 34 Sec. 7. Section 267A.2, Code 2025, is amended by adding the  
 4 35 following new subsection:

CODE: Defines "grocery store" under the Local Food and Farm Program.

5 1 NEW SUBSECTION 4A. "Grocery store" means the same as  
 5 2 defined in section 15.413.

5 3 Sec. 8. Section 267A.6, subsection 2, paragraphs a and c,  
 5 4 Code 2025, are amended to read as follows:

CODE: Allows the Local Food and Farm Program coordinator to sponsor and fund projects that do the following:

5 5 a. Improve communication and cooperation between and among  
5 6 farmers, food entrepreneurs, grocers, and consumers.  
5 7 c. Demonstrate the value of processing, distributing,

5 9 must be capable of being replicated on a statewide basis.
