Appropriates moneys in the Technology Reinvestment Fund (TRF) to the Department of Management (DOM) beginning in FY 2028 for the use of implementing State information technology projects and requires the DOM to prioritize projects based on criteria enumerated in the Bill.	Page 1, Line 1

- Provide for a clearinghouse of justice system information to coordinate with data resource agencies and assist others in the use of justice system data.
- Coordinate with data resource agencies to provide data and analytical information to federal, State, and local governments, and assist agencies in the use of criminal justice data.
- Provide technical assistance upon request to State and local agencies.
- Review data supplied by the HHS, the DOM, the Legislative Services Agency, the Iowa Supreme Court, and other departments or agencies for the purpose of determining the effectiveness and efficiency of the collection of such data.

1 1 Section 1. Section 8.57C, subsections 2, 3, and 4, Code
 1 2 2026, are amended to read as follows:
 1 3 2. Moneys in the fund in a fiscal year shall be used as
 1 4 appropriated by the general assembly for the acquisition
 1 5 of computer hardware and software, software development,
 1 6 telecommunications equipment, and maintenance and lease
 1 7 agreements associated with technology components and for the
 1 8 purchase of equipment intended to provide an uninterruptible
 1 9 power supply to the department of management to provide
 1 10 a stable funding source for implementation costs of state
 1 11 information technology projects that enhance the state's
 1 12 technology infrastructure, improve government services,
 1 13 and promote innovation and economic development, including
 1 14 but not limited to new information technology projects
 1 15 and infrastructure replacement efforts of a department or
 1 16 establishment, while protecting the privacy of residents of
 1 17 this state.

CODE: Appropriates moneys in the Technology Reinvestment Fund (TRF) to the Department of Management (DOM) for the use of implementing State information technology projects.

DETAIL: Currently, the General Assembly appropriates moneys from the TRF to various State agencies for technology projects in the annual Infrastructure Appropriations Bill.

By statute, \$17,500,000 is appropriated from the General Fund to the TRF pursuant to Iowa Code section [8.57C\(3\)](#). However, the General Assembly has instead appropriated money from the Rebuild Iowa Infrastructure Fund (RIIF) for this purpose. The General Assembly appropriated the following amounts:

- Actual FY 2024 = \$18,390,000
- Actual FY 2025 = \$21,131,873
- Estimated FY 2026 = \$18,269,217

4 11 Provisions included in a contract entered into pursuant to
4 12 this subchapter that impose terms or conditions prohibited by
4 13 this section are void as contrary to public policy. Such a
4 14 contract shall be interpreted and enforced as if the contract
4 15 did not include the prohibited terms or conditions. Prohibited
4 16 terms and conditions include all of the following:

4 17 1. A provision requiring the department or a supported
4 18 entity to defend, indemnify, hold harmless another person, or
4 19 otherwise assume the debt or liability of another person in
4 20 violation of Article VII, section 1, of the Constitution of the
4 21 State of Iowa.

4 22 2. A provision that seeks to impose a term that is unknown
4 23 to the department or supported entity at the time of signing
4 24 the contract or that can be unilaterally changed by an entity
4 25 other than the department or a supported entity.

4 26 3. A provision that violates chapter 13 by not allowing
4 27 the department or a supported entity to participate in its own
4 28 defense through representation by the attorney general.

4 29 4. A provision that grants to a person other than the
4 30 attorney general the authority to convey to a court or litigant
4 31 the state's consent to any settlement of a suit involving the
4 32 contract when such settlement could impose liability on the
4 33 state.

4 34 5. A provision that specifies that the contract is governed
4 35 by the laws of a foreign state or nation.

5 1 6. A provision that claims blanket confidentiality of the
5 2 contract's terms.

5 3 7. A provision that claims that payment terms, including but
5 4 not limited to cost proposals or other pricing information, of
5 5 the contract are confidential.

5 6 8. A provision that authorizes or requires a venue for
5 7 litigation other than an appropriate state or federal court
5 8 sitting in Iowa.

5 9 9. A provision that requires the department or a supported
5 10 entity to pay attorney fees, court costs, or other litigation
5 11 expenses in the event of a contractual dispute.

5 12 10. A provision that imposes on the department or a
5 13 supported entity binding arbitration or any other binding
5 14 extrajudicial dispute resolution process in which the final

 5 17 entity's right to a jury trial.

 5 21 other applicable law, or any cancellation charges, as such
 5 22 charges constitute pledges of the state's credit.
 5 23 13. A provision that obligates the department or a supported
 5 24 entity to pay a tax.
 5 25 14. A provision that imposes a prior notice obligation
 5 26 on the department or a supported entity as a condition for
 5 27 the automatic renewal of a software license. The department
 5 28 or a supported entity may provide notice of its intent to
 5 29 terminate a software license at any time before the renewal
 5 30 date established in the contract.
 5 31 15. A provision that obligates the department or a supported
 5 32 entity to accept risk of loss before the receipt of items or
 5 33 goods.
 5 34 16. A provision that obligates the department or a supported
 5 35 entity to have commercial insurance.

 6 2 entity to grant to a nongovernmental entity full or partial
 6 3 ownership of intellectual property developed pursuant to the
 6 4 contract when the intellectual property is developed in whole
 6 5 or in part using federal funding.
 6 6 18. A provision that limits the time in which the department
 6 7 or a supported entity may bring a legal claim under the
 6 8 contract to a period shorter than that provided in Iowa law.
 6 9 19. A boilerplate provision included in transactional
 6 10 documents received by the department or a supported entity that
 6 11 seeks to alter the terms of the contract or to impose new terms
 6 12 in the contract.

6 13 Sec. 4. NEW SECTION 8.95 CONTRACTS — REQUIRED TERMS.
 6 14 All of the following provisions shall be deemed to be
 6 15 included in a contract entered into by the department or a
 6 16 supported entity under this subchapter:
 6 17 1. GOVERNING LAW. The contract shall be governed by
 6 18 the laws of the state of Iowa, without giving effect to any
 6 19 conflicts of law principles of Iowa law that may require the
 6 20 application of another jurisdiction's law.

CODE: Requires certain provisions to be included in a contract entered into by the DOM or a supported entity.

- The contract will be governed by the laws of the State of Iowa without giving effect to any conflicts of law principles of Iowa law that may require application of another jurisdiction's law.

6 21 2. VENUE. Any litigation commenced in connection with the
 6 22 contract shall be brought and maintained in an appropriate
 6 23 state or federal court sitting in Iowa.

- Any litigation will be brought and maintained in an appropriate State or federal court setting in Iowa.
- Defines State data for the purpose of State contracts.

6 24 3. STATE DATA. "State data" means all data, records,
 6 25 information, or content, in any form, that is provided by a
 6 26 state governmental entity to a vendor or that is collected,
 6 27 generated, or otherwise obtained by the vendor in the course of
 6 28 providing a good or service to the state governmental entity.

6 29 "State data" does not include aggregated or deidentified data
 6 30 collected by the vendor and used exclusively for the vendor's
 6 31 internal purposes directly related to evaluating or improving
 6 32 system performance, ensuring reliability, evaluating product
 6 33 functionality, conducting system analytics, projecting needs
 6 34 through capacity planning, ensuring license compliance, or
 6 35 evaluating security. State data shall at all times remain the
 7 1 sole and exclusive property of the state, and the vendor shall
 7 2 use state data only as necessary to provide the contracted
 7 3 services to the state. Upon request, the vendor shall provide
 7 4 the state, at no cost, a current copy of all state data in a
 7 5 commercially reasonable and state-acceptable digital format
 7 6 that enables the state to readily use, transfer, or migrate
 7 7 the state data. Except to the extent retention of state data
 7 8 is required by law, the vendor shall, after confirming that
 7 9 the state has received a copy of the state data, permanently
 7 10 delete all state data upon the conclusion or termination of
 7 11 the contract. At all times, including any post-contract
 7 12 period in which state data is retained due to record retention
 7 13 obligations, the vendor shall protect state data in accordance
 7 14 with current state data protection policies.

7 15 Sec. 5. NEW SECTION 8.96 CONTRACTS — LIMITATION OF
 7 16 LIABILITY — PROHIBITED TERMS.

7 17 Notwithstanding section 8A.311, subsection 22, and rules
 7 18 adopted pursuant to that subsection, the director may include
 7 19 a contractual limitation of vendor liability in information
 7 20 technology goods and services contracts. A contractual
 7 21 limitation of vendor liability must take into consideration the
 7 22 public interest and the mitigation of risks associated with the
 7 23 use of information technology goods or services. Any portion
 7 24 of a contractual limitation of vendor liability that includes
 7 25 a repudiation of all liability for cybersecurity incidents or
 7 26 a limitation on the vendor's liability for intentional torts,

CODE: Allows the Director of the DOM to include contractual limitations of vendor liability in information technology goods and services contracts.

 8 5 WITH CHIEF INFORMATION SECURITY OFFICER.

8 6 In the interest of facilitating communication between
 8 7 the chief information security officer and other entities
 8 8 concerning security incidents and security breaches, all such
 8 9 communications and any documents generated based in whole or in
 8 10 part on such communications are confidential. Notwithstanding
 8 11 chapter 22 or any other provision of law to the contrary, the
 8 12 department shall not release such communications pursuant to
 8 13 state open records laws, and such communications shall not be
 8 14 received into evidence, subject to discovery, or otherwise
 8 15 used in a trial, hearing, or other proceeding in or before any
 8 16 court, regulatory body, or other authority of the state or a
 8 17 political subdivision of the state, unless the communications
 8 18 are subject to a protective order that prohibits further
 8 19 disclosure of such communications and requires any court
 8 20 filings of such communications to be made under seal. It is
 8 21 the intent of the general assembly that these prohibitions and
 8 22 restrictions also apply to federal courts, regulatory bodies,
 8 23 and other authorities and for purposes of federal open records
 8 24 laws, to the extent allowed by federal law and court rules.
 8 25 The chief information security officer shall not release such
 8 26 communications other than for any of the following purposes:
 8 27 1. Identifying a cybersecurity threat, including the source
 8 28 of the cybersecurity threat, or a security vulnerability, and
 8 29 then only to government officials for purposes of addressing
 8 30 the threat.
 8 31 2. Responding to, or otherwise preventing or mitigating,
 8 32 a specific threat of death, serious bodily harm, or serious

CODE: Requires all communication between the Chief Information Security Officer and other entities concerning security issues to be confidential, except for the following purposes:

- Identifying a cybersecurity threat or a security vulnerability, and then only to government officials for purposes of addressing the threat.
- Responding to or otherwise preventing or mitigating a specific threat of death, serious bodily harm, or serious economic harm.
- Responding to, investigating, prosecuting, or otherwise preventing or mitigating a serious threat to a minor, including sexual exploitation and threats to physical safety.
- Preventing, investigating, disrupting, or prosecuting an offense under State or federal law.
