FUNDING SUMMARY

Requires moneys in the Technology Reinvestment Fund (TRF) to be appropriated by the General Assembly to the Department of Management (DOM), beginning in FY 2028, to be used for the implementation of State information technology projects. The Bill requires the DOM to prioritize projects based on criteria enumerated in the Bill.

Page 3, Line 25

Repeals the \$17.5 million standing appropriation from the General Fund to the TRF under Iowa Code section [8.57C](#), beginning in FY 2027.

Page 4, Line 7

MAJOR INCREASES/DECREASES/TRANSFERS OF EXISTING PROGRAMS

Authorizes the DOM to maintain an integrated information system for data sharing that enables automated data sharing among the Executive Branch, the Judicial Branch, and local agencies.

Page 11, Line 32

Designates the DOM as the Iowa statistical analysis center to coordinate with data resource agencies to provide data and analytical information to federal, State, and local agencies. Allows the DOM to do the following:

Page 12, Line 1

- Have access to criminal justice information, except that of intelligence data and peace officer investigation reports maintained by the Department of Public Safety (DPS).
- Provide data analysis and reporting on issues that may affect the State's correctional population.
- Maintain a multiagency information system to track the progress of juveniles and adults who have been charged with a criminal offense.
- Count and track decision points for persons in the juvenile justice system, the welfare system, and the court system.

Removes requirements for the Department of Health and Human Services (HHS) to do the following:

Page 15, Line 7

- Provide the General Assembly with an analysis of current and proposed criminal code provisions.
- Provide for a clearinghouse of justice system information to coordinate with data resource agencies and assist others in the use of justice system data.
- Coordinate with data resource agencies to provide data and analytical information to federal, State, and local governments, and assist agencies in the use of criminal justice data.
- Provide technical assistance upon request to State and local agencies.

EXECUTIVE SUMMARY

DEPARTMENT OF MANAGEMENT, RECORDS, FUNDS, AND CONTRACTS BILL

- Review data supplied by the HHS, the DOM, the Legislative Services Agency, the Iowa Supreme Court, and other departments or agencies for the purpose of determining the effectiveness and efficiency of the collection of such data.
- Provide to the General Assembly analysis and recommendations based on potential disparity in sentencing and costs associated with the implementation of criminal code provisions.

STUDIES AND INTENT

Intent

Allows the DOM to determine which authorized tasks of the Iowa statistical analysis center to perform if the DOM lacks sufficient moneys or resources to implement the specified tasks.

Page 14, Line 2

Nonreversion

Allows moneys in the TRF to remain available for expenditure until the close of the fiscal year that ends two years after the end of the fiscal year that the appropriation was made. Interest or earnings on moneys in the TRF are credited to the TRF.

Page 5, Line 16

Required Report

Requires the DOM to report the status of all projects funded from the TRF to the General Assembly by January 15 of each year.

Page 5, Line 24

SIGNIFICANT CODE CHANGES

Restricts the sum of an interdepartmental transfer in a fiscal year to an appropriation that is not an entitlement appropriation from exceeding 100.0% of the appropriation enacted by the General Assembly.

Page 2, Line 3

Restricts appropriations for an unspecified total from being used for an interdepartmental transfer under Iowa Code section [8.39](#).

Page 3, Line 11

Increases the frequency with which a staff member of the DOM is subject to a national criminal history check from once every 10 years to once every 5 years.

Page 6, Line 2

Provides a list of prohibited terms for a contract entered into by the DOM or a supported entity. Inclusion of the prohibited terms voids those provisions of the contract.

2 1 Section 1. Section 8.39, subsection 2, Code 2026, is amended
2 2 to read as follows:

2 3 2. If the appropriation of a department, institution,
2 4 or agency is insufficient to properly meet the legitimate
2 5 expenses of the department, institution, or agency, the
2 6 director of the department of management, with the approval of
2 7 the governor, may make an interdepartmental transfer from any
2 8 other department, institution, or agency of the state having
2 9 an appropriation in excess of its needs, of sufficient funds
2 10 moneys to meet that deficiency. Such transfer shall be to an
2 11 appropriation made from the same funding source and within
2 12 the same fiscal year. The amount of a transfer made from an
2 13 appropriation under this subsection shall be limited to not
2 14 more than one-tenth of one percent of the total of all
3 1 appropriations made from the funding source of the transferred
3 2 appropriation for the fiscal year in which the transfer is
3 3 made. An interdepartmental transfer to an appropriation which
3 4 is not an entitlement appropriation is not authorized when
3 5 the general assembly is in regular session and, in addition,
3 6 the sum of interdepartmental transfers in a fiscal year to
3 7 an appropriation which is not an entitlement appropriation
3 8 shall not exceed fifty one hundred percent of the amount of
3 9 the appropriation as enacted by the general assembly. For the
3 10 purposes of this subsection, an entitlement appropriation is:

3 11 a. "Appropriation in excess of its needs" means the
3 12 amount appropriated by the general assembly for a purpose is
3 13 determined by the department, institution, or agency receiving
3 14 the appropriation to be more than the amount necessary to carry
3 15 out that purpose. An appropriation for an unspecified dollar
3 16 amount, whether the appropriation is limited to be sufficient
3 17 to carry out a particular purpose or is unlimited, shall not
3 18 be considered an appropriation in excess of a department's,
3 19 institution's, or agency's needs.

3 20 b. "Entitlement appropriation" means a line item
3 21 appropriation to the state public defender for indigent defense
3 22 or to the department of health and human services for foster
3 23 care, state supplementary assistance, medical assistance, or
3 24 for the family investment program.

CODE: Restricts the sum of an interdepartmental transfer in a fiscal year to an appropriation that is not an entitlement appropriation from exceeding 100.00% of the appropriation enacted by the General Assembly.

CODE: Defines "appropriation in excess of its need." Prohibits appropriations of unspecified dollar amounts from being considered appropriations in excess of needs.

DETAIL: Restricts appropriations for an unspecified total being used for an interdepartmental transfer under Iowa Code section [8.39](#).

CODE: Technical change.

CODE: Requires moneys in the Technology Reinvestment Fund (TRF) to be appropriated by the General Assembly to the Department of Management (DOM) to be used to implement State information technology projects.

DETAIL: Currently, the General Assembly appropriates moneys from the TRF to various State agencies for technology projects in the annual Infrastructure Appropriations Bill.

Pursuant to Iowa Code section [8.57C\(3\)](#), \$17,500,000 is appropriated from the General Fund to the TRF. However, in recent years, the General Assembly has instead appropriated moneys from the Rebuild Iowa Infrastructure Fund (RIIF) for this purpose. The General Assembly appropriated the following amounts:

- Actual FY 2024 = \$18,390,000
- Actual FY 2025 = \$21,131,873
- Estimated FY 2026 = \$18,269,217

CODE: Repeals the \$17,500,000 standing appropriation from the General Fund to the TRF beginning in FY 2027.

CODE: Removes Iowa Code language related to the FY 2026 RIIF appropriation to the TRF.

CODE: Requires the DOM to prioritize projects based on enumerated criteria in this subsection.

CODE: Requires the DOM to provide a prioritized list of proposed projects for funding from the TRF to the Governor to develop budgetary recommendations for the General Assembly for FY 2028 and each fiscal year thereafter.

 6 9 investigation may include, without limitation, a work history,
 6 10 financial review, request for criminal history data, and
 6 11 national criminal history check through the federal bureau of
 6 12 investigation. In addition, a contractor, vendor, employee, or
 6 13 any other individual performing work for the department, or an
 6 14 individual on the information technology staff of a supported
 6 15 entity, may be subject to a national criminal history check
 6 16 through the federal bureau of investigation at least once
 6 17 every ~~ten~~ five years, including, without limitation, any time
 6 18 the department or supported entity has reason to believe an
 6 19 individual has been convicted of a crime. The department may
 6 20 request the national criminal history check and, if requested,
 6 21 shall provide the individual's fingerprints to the department
 6 22 of public safety for submission through the state criminal
 6 23 history repository to the federal bureau of investigation.
 6 24 The individual shall authorize release of the results of the
 6 25 national criminal history check to the department and the
 6 26 applicable supported entity. The department shall pay the
 6 27 actual cost of the fingerprinting and national criminal history
 6 28 check, if any, unless otherwise agreed as part of a contract

6 35 Provisions included in a contract entered into pursuant to
7 1 this subchapter that impose terms or conditions prohibited by
7 2 this section are void as contrary to public policy. Such a
7 3 contract shall be interpreted and enforced as if the contract
7 4 did not include the prohibited terms or conditions. Prohibited
7 5 terms and conditions include all of the following:

7 6 1. A provision requiring the department or a supported
7 7 entity to defend, indemnify, hold harmless another person, or
7 8 otherwise assume the debt or liability of another person in
7 9 violation of Article VII, section 1, of the Constitution of the
7 10 State of Iowa.

7 11 2. A provision that seeks to impose a term that is unknown
7 12 to the department or supported entity at the time of signing
7 13 the contract or that can be unilaterally changed by an entity
7 14 other than the department or a supported entity.

7 15 3. A provision that violates chapter 13 by not allowing
7 16 the department or a supported entity to participate in its own
7 17 defense through representation by the attorney general.

7 18 4. A provision that grants to a person other than the
7 19 attorney general the authority to convey to a court or litigant
7 20 the state's consent to any settlement of a suit involving the
7 21 contract when such settlement could impose liability on the
7 22 state.

7 23 5. A provision that specifies that the contract is governed
7 24 by the laws of a foreign state or nation.

7 25 6. A provision that claims blanket confidentiality of the
7 26 contract's terms.

7 27 7. A provision that claims that payment terms, including but
7 28 not limited to cost proposals or other pricing information, of
7 29 the contract are confidential.

7 30 8. A provision that authorizes or requires a venue for
7 31 litigation other than an appropriate state or federal court
7 32 sitting in Iowa.

7 33 9. A provision that requires the department or a supported
7 34 entity to pay attorney fees, court costs, or other litigation
7 35 expenses in the event of a contractual dispute.

8 1 10. A provision that imposes on the department or a
8 2 supported entity binding arbitration or any other binding
8 3 extrajudicial dispute resolution process in which the final
8 4 resolution is not determined by the state.

CODE: Provides prohibited terms for a contract entered into by the DOM or a supported entity. Specifies that inclusion of the prohibited terms voids those provisions of the contract.

8 5 11. A provision that waives the department's or a supported
8 6 entity's right to a jury trial.

8 7 12. A provision that obligates the department or a supported
8 8 entity to pay late payment charges not consistent with section
8 9 8A.514, interest greater than allowed under section 8A.514 or
8 10 other applicable law, or any cancellation charges, as such
8 11 charges constitute pledges of the state's credit.

8 12 13. A provision that obligates the department or a supported
8 13 entity to pay a tax.

8 14 14. A provision that imposes a prior notice obligation
8 15 on the department or a supported entity as a condition for
8 16 the automatic renewal of a software license. The department
8 17 or a supported entity may provide notice of its intent to
8 18 terminate a software license at any time before the renewal
8 19 date established in the contract.

8 20 15. A provision that obligates the department or a supported
8 21 entity to accept risk of loss before the receipt of items or
8 22 goods.

8 23 16. A provision that obligates the department or a supported
8 24 entity to have commercial insurance.

8 25 17. A provision that obligates the department or a supported
8 26 entity to grant to a nongovernmental entity full or partial
8 27 ownership of intellectual property developed pursuant to the
8 28 contract when the intellectual property is developed in whole
8 29 or in part using federal funding.

8 30 18. A provision that limits the time in which the department
8 31 or a supported entity may bring a legal claim under the
8 32 contract to a period shorter than that provided in Iowa law.

8 33 19. A boilerplate provision included in transactional
8 34 documents received by the department or a supported entity that
8 35 seeks to alter the terms of the contract or to impose new terms
9 1 in the contract.

9 2 Sec. 5. NEW SECTION 8.95 CONTRACTS — REQUIRED TERMS.
9 3 All of the following provisions shall be deemed to be
9 4 included in a contract entered into by the department or a
9 5 supported entity under this subchapter:

9 6 1. GOVERNING LAW. The contract shall be governed by
9 7 the laws of the state of Iowa, without giving effect to any
9 8 conflicts of law principles of Iowa law that may require the
9 9 application of another jurisdiction's law.

9 10 2. VENUE. Any litigation commenced in connection with the

- The contract will be governed by the laws of the State of Iowa without giving effect to any conflicts of law principles of Iowa law that may require application of another jurisdiction's law.
- Any litigation will be brought and maintained in an appropriate State or federal court setting in Iowa.

9 11 contract shall be brought and maintained in an appropriate
 9 12 state or federal court sitting in Iowa.
 9 13 3. STATE DATA. "State data" means all data, records,
 9 14 information, or content, in any form, that is provided by a
 9 15 state governmental entity to a vendor or that is collected,
 9 16 generated, or otherwise obtained by the vendor in the course of
 9 17 providing a good or service to the state governmental entity.
 9 18 "State data" does not include aggregated or deidentified data
 9 19 collected by the vendor and used exclusively for the vendor's
 9 20 internal purposes directly related to evaluating or improving
 9 21 system performance, ensuring reliability, evaluating product
 9 22 functionality, conducting system analytics, projecting needs
 9 23 through capacity planning, ensuring license compliance, or
 9 24 evaluating security. State data shall at all times remain the
 9 25 sole and exclusive property of the state, and the vendor shall
 9 26 use state data only as necessary to provide the contracted
 9 27 services to the state. Upon request, the vendor shall provide
 9 28 the state, at no cost, a current copy of all state data in a
 9 29 commercially reasonable and state-acceptable digital format
 9 30 that enables the state to readily use, transfer, or migrate
 9 31 the state data. Except to the extent retention of state data
 9 32 is required by law, grant, or other governmental requirement,
 9 33 the vendor shall, after confirming that the state has received
 9 34 a copy of the state data, permanently delete all state data
 9 35 within a commercially reasonable period of time after the
 10 1 conclusion or termination of the contract. At all times,
 10 2 including any post-contract period in which state data is
 10 3 retained due to record retention obligations, the vendor shall
 10 4 protect state data in accordance with current state data
 10 5 protection policies.

10 6 Sec. 6. NEW SECTION 8.96 CONTRACTS — LIMITATION OF
 10 7 LIABILITY — PROHIBITED TERMS.
 10 8 Notwithstanding section 8A.311, subsection 22, and rules
 10 9 adopted pursuant to that subsection, the director may include
 10 10 a contractual limitation of vendor liability in information
 10 11 technology goods and services contracts. A contractual
 10 12 limitation of vendor liability must take into consideration the
 10 13 public interest and the mitigation of risks associated with the
 10 14 use of information technology goods or services. Any portion
 10 15 of a contractual limitation of vendor liability that includes
 10 16 a repudiation of all liability for cybersecurity incidents or

- Defines State data for the purpose of State contracts.

CODE: Allows the Director of the DOM to include contractual limitations of vendor liability in information technology goods and services contracts.

10 17 a limitation on the vendor's liability for intentional torts,
 10 18 criminal acts, fraudulent conduct, intentional or willful
 10 19 misconduct, gross negligence, death, bodily injury, damage to
 10 20 real or personal property, intellectual property violations,
 10 21 liquidated damages, compliance with applicable laws, violations
 10 22 of confidential information obligations, or contractual
 10 23 obligations of the vendor pertaining to indemnification shall
 10 24 be void as a matter of law as contrary to public policy. A
 10 25 contractual limit of vendor liability that does not apply
 10 26 equally to the contracted parties or that limits a vendor's
 10 27 liability to less than the contract value inclusive of all
 10 28 possible extensions is void as a matter of law as contrary to
 10 29 public policy.

10 30 Sec. 7. NEW SECTION 8.97 CONFIDENTIALITY OF COMMUNICATIONS
 10 31 WITH CHIEF INFORMATION SECURITY OFFICER.
