Major Language Differences:

- College Student Aid Commission – Senate adds language that requires a study of the Tuition Grant Program funding to address issues related to for-profit and non-profit institutions. The Senate also returns the appropriation to one line-item (rather than two) and eliminates all references to nonprofit or profit. Ashford University students are held harmless in both the House and Senate versions.
- Department of Education –
 - Value-Added Assessment System: Senate adds language directing the Department to issue a Request for Proposal (RFP) for a value-added assessment system provider to calculate the annual academic growth of each student in grades 3 through 11. By FY 2007, each school district is required to submit Iowa Test of Basic Skills (ITBS) and Iowa Test of Educational Development (ITED) scores to the provider for analysis. Districts may select an alternate value-added assessment system that is statistically valid and reliable. Senate allocates money for this purpose from the Student Achievement and Teacher Quality Program (see below).
 - Empowerment: Senate allocates the following:
 - \$300,000 to the Office of Empowerment in the Department of Management. Of that amount, \$50,000 is allocated to administer the Early Childhood Coordinator’s position created in HF 761 (Early Childhood Policy Bill), if enacted. Also of that amount, \$50,000 is allocated to implement an Early Childhood Iowa web site.
 - \$4.7 million to assist low-income parents with preschool tuition.
 - \$1.0 million for professional development for child care and preschool providers.

- Department of Education (continued) –
 - Teacher Quality –
 - Team-Based Variable Pay: Senate does not allocate funds to Team-Based Variable Pay for FY 2006. House allocated \$500,000 for FY 2006.
 - National Board Certification Awards: Senate extends the registration deadline to June 30, 2006, to receive one-time reimbursement of up to one-half of the registration fee, and extends the registration deadline to January 1, 2006, to receive the annual awards.
 - Beginning Teacher Mentoring and Induction: Senate allocates \$4.2 million from General Fund appropriation to the Student Achievement and Teacher Quality Program. House allocated \$4.1 million for this purpose.
 - Career Development and Evaluator Training: Senate combines the two programs and allocates \$485,000 for FY 2006. Of that amount, \$85,000 is allocated to the Ambassador to Education. House funded only Career Development at \$175,000 and funded the Ambassador to Education out of another allocation (see Additional Contract Day below).
 - Additional Teacher Contract Day(s): Senate allocates \$10.0 million for one additional teacher contract day for professional development. House allocated \$8.9 million for one day and, from that amount, allocated \$75,000 to the Ambassador to Education. House also allocated an additional \$8.9 million for a second day in HF 882 (Standings). Funding an additional day for all classroom teachers is estimated to cost \$8.9 million. Funding an additional day for all school district employees receiving salary funding under the Student Achievement and Teacher Quality Program is estimated to cost \$10.0 million.
 - Value-Added Assessment System: Senate allocates \$1.0 million for purposes of the Value-Added Assessment System.
 - Community Colleges: Senate adds language establishing a formula for allocating the annual State general aid appropriation between the community colleges.
 - Nonpublic School Textbooks: Senate amends Section 301.1(2), Code of Iowa, to provide that textbooks made available by a school district to pupils attending accredited nonpublic schools are not the property of the school district.
- Institute for Tomorrow's Workforce – The Senate adds language converting the Institute to a foundation and adds language permitting employment of an executive director.
- Board of Regents – The House allocates \$50,000 of new funding in HF 816 for Iowa State University (ISU) to the Veterinary Medicine Diagnostic Lab. The House increases the allocation to \$1,000,000 in HF 882 (Standings). The Senate changes the allocation to \$127,000. Also, the Senate requires ISU to complete a study regarding operations, fees, and business structure of the Lab as it compares to similar labs, and submit recommendations to the Governor and the General Assembly by October 1, 2005.
