BILL SUMMARY

**HEALTH CARE TRANSFORMATION
ACCOUNT CHANGES**

**EFFECTIVE AND RETROACTIVE
APPLICABILITY DATES**

- The changes in this Bill are necessary to satisfy the terms of a revised agreement with the federal Centers for Medicare and Medicaid Services (CMS) regarding implementation of HF 841 (IowaCare Medicaid Reform Act). Also, allows for a transfer from the University of Iowa to be used as a match for federal funds.
- Requires the Department of Human Services (DHS) to adjust hospital payments and provide a payment of \$20.2 million to the University of Iowa Hospitals and Clinics (UIHC). (Page 1, Line 19)
- Provides for a supplemental payment adjustment of \$34.4 million for physician services provided to Medicaid patients by the Carver College of Medicine at the University of Iowa. (Page 2, Line 8)
- Requires the University of Iowa to transfer \$54.6 million to the State General Fund. This total is equal to the FY 2004 and FY 2005 General Fund appropriations to the University of Iowa for the Indigent Patient Program. Of the funds transferred by the University, \$19.4 million is appropriated to the Medical Assistance Account and \$35.3 million to the Health Care Transformation Account. (Page 2, Line 34)
- Appropriates \$2.0 million to the UIHC from the Health Care Transformation Account. (Page 3, Line 14)
- The Bill takes effect upon enactment. The provisions amending 2003 and 2004 Iowa Acts are retroactive to May 2, 2003, and May 17, 2004 respectively. (Page 4, Line 9)

 1 2 2005, is amended to read as follows:

 1 4 the state treasury under the authority of the department.

CODE: Clarifies revenue sources for the Health Care Transformation Account.

DETAIL: This change is necessary to allow a transfer from the University of Iowa Hospitals and Clinics (UIHC) to be used as a match for federal funds. The UIHC transfer is required in Section 4.

CODE: Requires the DHS to adjust hospital payments and provide a payment adjustment of \$20,216,039 to the UIHC.

DETAIL: This change is necessary to satisfy the terms of a revised agreement with the federal Centers for Medicaid and Medicare Services (CMS) regarding implementation of the Medicaid Reform authorized during the 2005 Legislative Session in HF 841 (IowaCare Medicaid Reform Act). Medicaid reform was implemented as a result of the federal elimination of intergovernmental transfers (IGTs).

CODE: Provides for a one-time payment adjustment for physician services provided to Medicaid patients by the Carver School of Medicine at the University of Iowa. This amount is set at \$34,423,090.

DETAIL: This change is also necessary to satisfy the terms of the revised agreement with the CMS.

2 34 Sec. 4. TRANSFER, APPROPRIATION, AND DEPOSIT OF FUNDS.

Requires the University of Iowa to transfer \$54,639,129 to the State

2 35 Upon receipt of the supplemental payments described in
 3 1 sections 2 and 3 of this Act, the university of Iowa shall
 3 2 transfer to the general fund of the state, from whatever
 3 3 source available, \$54,639,129, which is an amount equal to the
 3 4 appropriations made pursuant to 2003 Iowa Acts, chapter 182,
 3 5 section 9, subsection 2, paragraph "b", as modified by
 3 6 executive orders 31 and 36, and pursuant to 2004 Iowa Acts,
 3 7 chapter 1175, section 86, subsection 2, paragraph "b". Of the
 3 8 amount transferred to the general fund of the state pursuant
 3 9 to this section, \$19,350,061 is appropriated and shall be
 3 10 deposited in the medical assistance account of the department
 3 11 of human services and \$35,289,068 is appropriated and shall be
 3 12 deposited in the account for health care transformation
 3 13 created in section 249J.23.

General Fund upon receipt of the payment adjustments specified in Sections 2 and 3. The total is equal to the FY 2004 and FY 2005 General Fund appropriations to the University for the Indigent Patient Program (State Papers). Of the funds transferred by the University, \$19,350,061 is appropriated and deposited into the Medical Assistance Account of the DHS and \$35,289,068 is appropriated and deposited in the Health Care Transformation Account.

DETAIL: This amount is a change from HF 841, which provided net revenues of \$38.5 million. Pursuant to HF 841 and the federal agreement, the \$35.3 million is a one-time appropriation that is required to be used to implement the Health Care Reform Initiatives specified in HF 841.

3 14 Sec. 5. APPROPRIATION -- HEALTH CARE TRANSFORMATION
 3 15 ACCOUNT. There is appropriated from the account for health
 3 16 care transformation created in section 249J.23, to the
 3 17 university of Iowa hospitals and clinics for the fiscal year
 3 18 beginning July 1, 2005, and ending June 30, 2006, the
 3 19 following amount, or so much thereof as is necessary, for the
 3 20 purposes designated:
 3 21 For provision of services pursuant to and for costs
 3 22 associated with chapter 249J:
 3 23 \$ 2,000,000

Health Care Transformation Account appropriation to the UIHC for costs related to providing IowaCare services.

DETAIL: This appropriation is intended to increase the amount of federally matched IowaCare services that the UIHC can provide. The UIHC is expected to generate \$2,000,000 in additional claims beyond what was specified in House File 841 and to draw down a federal match for these claims.

3 24 Notwithstanding section 8.33, moneys appropriated in this
 3 25 section that remain unencumbered or unobligated at the close
 3 26 of the fiscal year shall not revert, but shall remain
 3 27 available for expenditure for the purposes designated until

CODE: Permits nonreversion of funds.

3 29 Sec. 6. ACTIVITIES SUBSEQUENT TO TRANSFER AND PAYMENTS.
 3 30 Subsequent to the transfer of funds by the university of Iowa
 3 31 to the general fund of the state pursuant to section 4 of this

Specifies that once the transfer of funds from the University of Iowa to the General Fund is complete, the DHS is solely responsible for any related fines, penalties or repayment of funds assessed by any State

3 32 Act, the supplemental payments made to the university of Iowa
3 33 hospitals and clinics and to the carver college of medicine
3 34 faculty practice plan by the department of human services
3 35 pursuant to sections 2 and 3 of this Act are irrevocable,
4 1 notwithstanding any subsequent decision by the centers for
4 2 Medicare and Medicaid services of the United States department
4 3 of health and human services or any other state or federal
4 4 agency. The department of human services is solely
4 5 responsible for any repayment or payment of any penalty or
4 6 fine assessed by any state or federal agency on any party

4 9 Sec. 7. EFFECTIVE AND RETROACTIVE APPLICABILITY DATES.
4 10 1. This Act, being deemed of immediate importance, takes
4 11 effect upon enactment.
4 12 2. The provision of this Act amending 2003 Iowa Acts,
4 13 chapter 112, section 11, is retroactively applicable to May 2,
4 14 2003.
4 15 3. The provision of this Act amending 2004 Iowa Acts,
4 16 chapter 1175, section 86, is retroactively applicable to May
4 17 17, 2004.

Specifies that the Bill takes effect upon enactment. Also, specifies that the provisions amending the 2003 and 2004 Iowa Acts are retroactive to May 2, 2003, and May 17, 2004, respectively.

4 18 EXPLANATION
4 19 This bill revises the mechanisms to provide funding for the
4 20 purposes of the health care transformation account. Instead
4 21 of requiring the university of Iowa hospitals and clinics
4 22 (UIHC) to transfer the amount of the increase resulting from
4 23 hospital payment adjustments during fiscal year 2004-2005 and
4 24 from supplemental payment adjustments for physician services
4 25 provided to medical assistance patients during fiscal years
4 26 2003-2004 and 2004-2005 back to the department of human
4 27 services, the department of human services will pay the UIHC
4 28 and the carver college of medicine faculty practice plan a
4 29 specific amount for each payment adjustment, which the UIHC

4 30 and the carver college of medicine faculty practice plan will
4 31 retain. Once the payment adjustment amounts are received, the
4 32 university of Iowa will transfer to the general fund of the
4 33 state, \$54,639,129, from whatever sources available, which is
4 34 an amount equal to the amounts appropriated from the general
4 35 fund of the state to the UIHC for the indigent care program
5 1 for FY 2003-2004 and FY 2004-2005. This amount is then
5 2 appropriated and is divided into specified amounts for deposit
5 3 into the medical assistance account of the department of human
5 4 services and into the account for health care transformation.
5 5 The bill also provides that once the transfer of funds by
5 6 the university of Iowa to the general fund of the state is
5 7 made, the supplemental payments made to the university of Iowa
5 8 hospitals and clinics and the carver college of medicine
5 9 faculty practice plan by the department of human services are
5 10 irrevocable, notwithstanding any subsequent decision by state
5 11 or federal agencies, and the department of human services is
5 12 solely responsible for any repayment or payment of any penalty
5 13 or fine assessed by any state or federal agency on any party
5 14 relative to those transactions.
5 15 The bill also makes an appropriation from the account for
5 16 health care transformation to the University of Iowa hospitals
5 17 and clinics of \$2 million for FY 2005-2006.
5 18 The bill takes effect upon enactment and portions of the
5 19 bill are retroactively applicable.
