**FY 2008 ALLOWABLE GROWTH**

- Sets the FY 2008 school foundation allowable growth rate at 4.0%. This will increase the school district cost per pupil by \$205 compared to the FY 2006 amount. The FY 2008 State cost per pupil will be \$5,333. (Page 1, Line 1)
- **FISCAL IMPACT:** With 4.0% allowable growth:
  - State Aid will total \$2,151.9 million, which is an increase of \$103.2 million (5.0%) compared to the current estimate for FY 2007.
  - Foundation Property Tax would total \$1,111.6 million, which is an increase of \$21.5 million (2.0%) compared to the current estimate for FY 2007.
  - The budget guarantee would total \$8.7 million (this amount is included in the total Foundation Property Tax amount), and 107 school districts would be eligible to receive the budget guarantee. Of these school districts, 20 would receive the 101.0% budget adjustment, and 87 would receive the scaled-down budget adjustment.

Budget enrollments are based on Department of Education 2005 projections and may be updated if new projections become available. Each school district's spending authority is determined by multiplying the district cost per pupil by the weighted enrollment, yielding the combined district cost. The combined district cost has three components. First, the school district receives funding from the Uniform Levy (\$5.40 per \$1,000 taxable valuation). Next an appropriation from the State General Fund pays the difference between the amount raised by the Uniform Levy and the Foundation Level (87.5% of the regular program costs and special education costs and 79.0% of the AEA special education costs). The Additional Levy property tax makes up the remainder.

The Budget Guarantee is a mechanism to provide additional funding for school districts with declining enrollments. It is funded with property taxes and is included in the Foundation Property Taxes. A phase out of the Budget Guarantee began in FY 2005.

The \$7.5 million AEA reduction is applied to FY 2007 and FY 2008, rather than the \$19.3 million reduction applied in FY 2006.

FY 2006 valuations increased by 2.3%; FY 2007 valuations are estimated to increase 4.74%; and FY 2008 valuations are projected to increase by 2.00%.

Foundation Property Taxes include the Uniform Levy and the Additional Levy with adjustments for Utility Tax Replacement.

The Department of Education has provided by-district estimates for special education and supplementary weightings for FY 2007.
