EXECUTIVE SUMMARY JUSTICE SYSTEM APPROPRIATIONS BILL

FUNDING SUMMARY

• Appropriates a total of \$529.0 million from the General Fund for FY 2013 to the Departments of Justice, Corrections, Inspections and Appeals, Public Defense, Public Safety, and Human Rights, the Iowa Law Enforcement Academy, Board of Parole, and Civil Rights Commission. This is an increase of \$15.4 million compared to estimated net FY 2012. This Bill also appropriates a total of \$13.5 million from other funds for FY 2013 reflecting no change compared to estimated net FY 2012.


