## EDUCATION APPROPRIATIONS BILL Conference Committee Report

**Funding Summary:** House File 604, as proposed by the Conference Committee, appropriates a total of \$898.2 million from the General Fund and 12,372.9 FTE positions for FY 2014. This is an increase of \$37.2 million and 96.3 FTE positions compared to estimated FY 2013. Most of the FTE position increase is due to positions for the Board of Regents that had been appropriated by another subcommittee in previous years.

House File 604 also appropriates \$66.0 million from other funds for FY 2014. This is an increase of \$66.0 million compared to estimated FY 2013.

House File 604 also appropriates money from the General Fund and other funds for FY 2015. Each of the FY 2015 General Fund and other fund appropriations represents 50.0% of the FY 2014 appropriation. #### Language Summary:

NOTE: This language summary represents major language provisions and should not be considered an all-inclusive comprehensive listing.

- Online Curriculum for Uniform Transfer of Academic Credit Study and Report: Requires the Department of Education to conduct a study regarding the establishment of an online curriculum to facilitate the transfer of academic credits earned by students residing in child foster care facilities to public and accredited nonpublic schools. The report is due to the General Assembly by January 3, 2014.
- Early Childhood Iowa (ECI) Area Board Restrictions: Restricts membership on ECI area boards to no more than one member representing the same entity or interest. Restricts ECI area boards from providing services to or for the area board.
- ECI Home Visitation Program: Includes statutory language to add a schedule for phasing in a funding priority for home visit programs that use evidenced-based or promising models under the Healthy Opportunities for Parents to Experience Success (HOPES) Healthy Families Iowa (HFI) program (HOPES-HFI) and the Early Childhood Iowa (ECI) Initiative.
- UNI Math and Science Collaborative: Removes the \$282,000 cap on the amount of the appropriation that can be spent for salaries. Permits up to \$1.0 million of the General Fund appropriation to be used to provide technology education opportunities to high school, career academy, and community college students through public-private partnerships.
- Rural Primary Care Loan Forgiveness: Reduces the maximum annual payment to eligible recipients from \$50,000 to \$40,000 and extends the number of years from four to five. Specifies that a loan recipient who fails to fulfill the service requirements must repay the loan with interest and may also be subject to repaying moneys advanced by the service commitment area.
- Rural lowa Advanced Registered Nurse Practitioner and Physician Assistant Loan Repayment Program: Creates a new program and fund to provide loan repayments to nurse practitioners and physician assistants who agree to practice in a rural service area for five years.
- Board of Regents Tuition Use for Student Financial Aid: Prohibits the use of a portion of resident undergraduate student tuition for student aid purposes but permits such usage for nonresident student tuition.
- Area Education Agencies (AEAs): Authorizes the AEAs to sell software and support services, professional development programs and materials, online professional development, and online training to entities within the State other than school districts, to school districts and other public agencies outside the State, and to Iowa school districts when such services and programs are not otherwise required by statute.

• Student Achievement and Teacher Quality Allocations: Allocates the \$6.3 million for the Student Achievement and Teacher Quality appropriation as follows.

- Workforce Training Programs: Provides the following:
  - Permits the Department of Education to use up to \$100,000 of a General Fund appropriation for administration of the Workforce Training and Economic Development Funds at the community colleges.
  - Permits the Department of Education to use up to \$150,000 of a General Fund appropriation for implementation of adult education and literacy programs.
  - Specifies that no more than \$1.5 million of the Adult Literacy for the Workforce appropriation may be used for adult basic education programs for students requiring instruction in English as a second language.
  - Requires \$210,000 of a General Fund appropriation to be transferred to the Department of Human Services for a pilot project to provide supplemental support services for international refugees.
  - Specifies that the University of Iowa (UI) and Iowa State University (ISU) will each receive 35.0% of the Regents Innovation Fund appropriation and the University of Northern Iowa (UNI) will receive 30.0%. Requires each university to provide a one-to-one match of funding. Requires the Board of Regents to submit an annual report on the use of the Innovation Fund appropriation.
  - Requires ISU to allocate at least \$736,000 of the ISU Economic Development appropriation to small business development centers. Specifies other requirements for the funds. Requires ISU to submit an annual report on the use of the funds.
  - Specifies requirements for the UI Economic Development appropriation.
  - Requires the UNI to allocate at least \$618,000 of the UNI Economic Development appropriation to support entrepreneurs through the regional business center and economic gardening program.
  - Specifies that no more than \$50,000 from the Skilled Workforce Shortage Tuition Grant appropriation may be used for expenses associated with the Secondary Career and Technical Programming Task Force.
  - Creates the lowa Skilled Worker and Job Creation Fund separate from the State General Fund. Monies in the Fund will not revert to any other fund.
  - Changes responsibility for the administration of the Workforce Training and Economic Development Funds from the Economic Development Authority to the Department of Education.

- Makes a variety of changes to the statute establishing the Statewide Work-Based Learning Intermediary Network.
- Requires the Department of Education and the community colleges to jointly implement adult education and literacy programs to assist adults and youths 16 years of age and older that are not in school.
- Increases the amount of advance funding that may be provided to a business participating in a program under the Iowa Jobs Training Act (Code Chapter 260F).
- Establishes a Fund for the PACE Program and specifies that no more than \$5.0 million may be awarded annually from the Funds. Specifies that the monies in the Fund do not revert. Specifies that PACE Program funds may be used to employ Pathway Navigators and specifies the services those employees will provide. Specifies that PACE Program funds may be used to provide staff and support for the development and implementation of regional industry sector partnerships.
- Increases the limit on participation in the Gap Tuition Assistance Program to those with incomes at or below 250.0% of the federal poverty level. Limits the percentage of total funding each community college may use to provide support services for the Gap Tuition Assistance Program.
- Adds joint infrastructure projects between school districts and community colleges for purposes of offering shared or concurrent enrollment courses to the list of purposes for revenues from the Secure an Advanced Vision for Education (SAVE) Fund. Specifies that such use does not require voter approval.
- Requires the Department of Education to convene a task force to review current secondary career and technical programming offered by community colleges and make recommendations for programming to reduce skill shortages, enhance economic growth and ensure students have access to high quality globally competitive programs.
- Requires the Board of Regents to submit a report by January 15, 2014, on progress in meeting the strategic plan for technology transfer and economic development.
