This summary highlights the language and policy differences between the SF 2324 as passed by the Senate and the House amendment. All differences associated with appropriations are included on the attached spreadsheet.

Not included in the Senate Bill	ILEA Major Maintenance Priority: House amendment requires that health, life, and safety projects at the Iowa Law Enforcement Academy be given priority for funding from the major maintenance appropriation.
Iowa Nutrient Research Center: Allocates \$450,000 from the Water Quality Initiative appropriation to the Iowa Nutrient Research Center at Iowa State University to be used for nutrient water monitoring network technology and equipment.	Not included in the House amendment.
Rural YMCAs: The Senate bill provides funding for rural YMCAs in cities with a population of less than 35,000.	House amendment changes the city population eligibility to 28,000.
Emergency Youth Shelters: Amends FY 2016 appropriation requirements associated with a grant to expand a Polk County emergency youth shelter. The amended language allows the grant recipient to be reimbursed for infrastructure costs incurred during a prior fiscal year. The grant recipient may also use expenditures and in-kind contributions incurred in any fiscal year as matching funds.	Not included in the House amendment.

Shallow Lakes: Establishes the Shallow Lakes Program and allocates between 8.0% and 12.0% of the Lake Restoration appropriation to fund the Program.	Not included in the House amendment.
Salary Restriction on Infrastructure Funds: Prohibits funds appropriated for public vertical infrastructure projects from being used for salaries of restricted employees beginning in FY 2017.	Not included in the House amendment.
Property Purchase: Allows the Executive Council to purchase Elim Fellowship Church located adjacent to the Capitol Complex.	Not included in the House amendment.
Not included in the Senate Bill	Reversion Date Change: Extends the reversion date for multiple TRF appropriations totaling \$14.4 million that were made to the DHS during the 2011 Legislative Session for Medicaid technology upgrades. The language allows the department to expend the appropriated funds through the end of FY 2020.
