

I grew up in McLean, Va. and had a friend who would pick her up at the airport, take her there and return her to her flight back to New Orleans. I insisted even after she attempted suicide trying to hint to her oblivious parents that something was wrong.
- 2) When and where did the abortion occur?_see above
- 3) How old were you? I was 20, so was she_ Were you married? Yes No; (we finally did get married in 1973)

- 5) Did you encourage or pressure her to have an abortion? Yes No Please explain: Very much so! In high school I'd read so much about over population and I had had such a hard childhood... I justified that it was the only fair thing to do- to "protect it" from having to go thru what I did.
- 6) Did you offer to help her if she kept the baby? Yes No Please explain: That was never openly considered by me, although I now know that secretly, I am very sure, that is what she dreamed of; she just didn't have the gumption to defy the momentum set in motion by "our" plans.

After Leah, she and I, and all the "friend and relations," "agreed" that she should have her tubes tied. It was logical and for the best. However, it quickly became evident to me that she had never desired to do this and in fact she immediately began have "re-enastimosis" (re-tying the tubes) procedures. She soon dropped into deep clinical depressions and would often scratch/cut on her wrists while frantically sewing (just so she could "feel" something.) We sought help thru the mental health community who put her on Lithium, Elavil, and such which she constantly used to overdose on. I was then given the task of controlling her meds; so she just went to the clinic one day in June of '83 and said she was out. They gave her another 30 days worth which she secreted away. On evening of the 22nd she took them all and, this time, failed to tell me soon enough. She was dead by 11PM. The coroner ruled it accidental over dose, but, she was a very smart woman, she KNEW overdosing would kill her. And it did. Months later I began to struggle with depression, as have her daughters.

Sarah, Rachel, and Leah were 6, 5, and 4 when I had to gather them in my arms and tell them their mother had died (in reality? committed suicide.) To this day they still struggle with it. I fully surrendered to God in '85 and married Carolyn (and her 13 year old daughter Joy) in '87. I wish that I could say that all was perfect after that, but I can't. (Those are other stories) However, the grace of God has kept me, Carolyn, and our 2 subsequent daughters Rebekah and Jordan (now 19 and 17 respectively.) The other 4 girls had experiences with God but have strayed. (I pray constantly for them.)

However in retrospect, it has become very evident to me that she no doubt suffer PTSD from having killed her child and that it became an obsessive drive to keep having more children to make up for that loss and the loss of her identity as a woman and as a mother (not to mention the guilt she carried and was so unfortunately in capable of resolving; based on the trivia fed to us by the Catholic church, which we had joined searching for answers and absolution). Killing the child did nothing but bring turmoil. Only God's Grace has is daily causing us to overcome the turmoil.

In a nutshell, my insistence that my first child (Benjamin) be killed has been a decision that has tormented all of my life. Yes! I found the total forgiveness available through my Lord and Savior Jesus Christ-and my sins are "as far as the East is forming the West." But the consequences of those "convenient" decisions will always taint my li and the lives of my family members. Killing an innocent child in the mother's womb only sets in motion a world of other "problems" that will hide only for so long before they creep back in and take over. Yes, it was legal for me to have my child killed. Had it not been so easy, I wonder how things may have turned out...had Benjamin lived.




