

programs, pursuing new research investment funds, and establishing renewable energy performance measures.

The director and office are also responsible for leading in the development of an Iowa Energy Independence Plan and administering the Iowa Power Fund to invest in research and development, commercialization, education, and other projects to advance Iowa’s leadership in the new energy economy.

The 18-member Iowa Power Fund Board is responsible for advising the director on the strategic direction of the fund, and approves the money of the fund for use to support grants, loans, and other financial incentives. The seven-member Due Diligence Committee is created to review applications that are submitted to the board for financial assistance from the fund. The committee, after thorough review, may provide recommendations to the board for expenditure of the moneys in the fund.
