For a group of older girls—ages 15 to 17—the prospect of living independently when they age out of the system is bleak and terrifying. With histories of multiple placements or failed foster care, doing poorly with academics, fighting the effects of physical or sexual abuse, coping—or not coping—with drug or alcohol addiction, these girls must learn to live on their own.

And this must happen as they face other problems associated with teenage girls — low self-esteem, distorted self-image, intense peer relationships and the absence of successful role models.

Alternative Services' new Girls' Treatment Center will provide the supervised, residential setting needed for girls to transition to living successfully on their own. No other residential program in Iowa treats older girls using a gender-specific approach to programming. Without help their chaotic lives will continue minus the life skills, work skills or education

needed to buffer the challenges of their futures. Later, unwanted pregnancies and a lifetime on welfare close their poverty circles.

Building on a 22-year history of successful treatment of highrisk teenagers including the Anita Daniels Pre-Independent Living Program for boys, Alternative Services is creating an innovative, genderspecific program for older girls.

Scheduled to open in late fall of 2002 on the agency's Horizon Center campus in Marion, the new Girls' Treatment Center will reach out to a widely underserved group of girls helping them to leave the system and face the world as successful adults.

For these young women and our communities, this is a critical 'about face.'

- Alternative Services, a Cedar Rapids-based human services agency serving eastern Iowa, seeks to provide a model, pre-independent living program for court-ordered girls ages 16 to 18 years old, to prepare them to live successfully on their own before they age out of the juvenile system.
- The new Girls' Treatment Center to be located in Marion, Iowa, is designed for girls who are transitioning from high-structure placements, and is a counterpart to the agency's established Anita Daniels Pre-Independent Living Program for boys.
- Area legislators, Juvenile Court judges and Juvenile Court officers widely support the need for this program as no comparable program currently exists.
- This will be the first gender-specific, residential program of its kind in Iowa and will accept referrals from across the state as the Anita Daniels boys' program currently does.



Agency background -

- Alternative Services has been serving Iowa's youth with a variety of programs since 1979 when the agency pioneered supervised independent living in Iowa. The agency is accredited by the Council on Accreditation, one of only 14 agencies in the state to hold this level of professional accreditation.
- During FY 2000-01 approximately 3,000 children and families in 55 counties received our services. The agency presently offers a continuum of services through offices and programs based in Cedar Rapids, Marion, Hiawatha, Davenport, Decorah, Dubuque, Mason City, Tama, Tipton, and Waterloo.
- The organization has earned a solid reputation for successful treatment of court-ordered adolescents and teens through early intervention.
