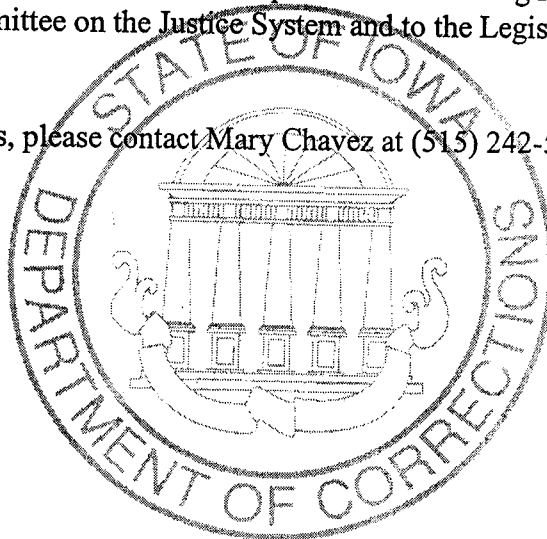
SUBJECT: Legislative Report: Offender Fees - Pay For Stay
